None. The Land Use Advisory Committee will consider a revised work plan for approval in 2021.

Background

The Land Use Advisory Committee (LUAC) develops an annual work plan to guide its business and meeting agendas. The LUAC Bylaws, statutory requirements, and input needed for key projects inform the work plan. The draft work plan prioritizes time-sensitive projects and includes several topics planned for 2020 but delayed until 2021. The timing of agenda topics may shift, especially given uncertainties during Covid-19. The LUAC Chair may modify the work plan when approving agendas.

Meeting dates are scheduled on:

January 21, March 18, May 20, July 15, September 16, and November 18

Goals for the work plan include:

- Advise the Council on land use, comprehensive planning, and other planning
- Emphasize changes affecting land use, impacts of Covid-19, and implications for comprehensive plans and policy development
- Prioritize opportunities for substantive input
- Influence communication of policies, initiatives, and resources for local governments
- Center equity in the Committee's work

Examples of topics LUAC discussed since the Metropolitan Council appointed members in 2019 include:

- Livable Communities Act (LCA) programs, including Tax Based Revitalization Account (TRBA), Livable Communities Demonstration Account (LCDA), Livable Communities Demonstration Account – Transit Oriented Development (LCDA-TOD), Local Housing Incentives Account (LHIA), and Housing Action Plan for LCA participation 2021-2030
- Metro Climate Stats project, including *Greenhouse Gas Inventory*
- Equity approach for integrating equity into Committee discussions
- <u>Suburban Change in Twin Cities Region</u> information, visual tool, and resources library
- <u>Climate Vulnerability Assessment (CVA)</u> tools to help planners integrate resiliency strategies into local comprehensive plans
- Water Supply Planning in the Twin Cities Metropolitan Area (2005-2020)
 report to the Minnesota Legislature and December 5, 2019 Joint
