#### **BUSINESS**

2013-40 2013 Unified Operating Budget Amendment

It was moved by Cunningham, seconded by Kramer, that the Metropolican Council amend the 2013 Unified Operating Budget to increase expenditures by \$3,318,781 funding through the use of Wastewater Operating Contingency Reserves.

Motion carried.

2013-43 2013 Unified Capital Program and Amendment

It was moved by VanEyll, seconded by Kramer that the Metropolitan Council:

 Amend the 2013 Authorized Capital Program (multi-year authorization) by increasing spending authority as follows:

Metro Transit \$ 10,580,248

 Amend the 2013 Capital Budget (annual appropriation) by increasing appropriations as follows:

Metro Transit New Authorizations \$ 10,580,248

Metro Transit Existing Authorizations Carry Forward \$ 167,225,299

 Approve the changes to capital projects as detailed in Tables 3, 3A and 9 and in Attachment 1

2013-71 Authorization to Enter into a Labor Agreement with Metropolitan Council Management Association (MANA)

It was moved by Kramer, seconded by Melander that the Metropolitan Council authorize the Regional Administrator to enter into a labor agreement with the Metropolitan Council Management Association, effective January 1, 2013 through December 31, 2015.

2013-72 Authorization to Enter into a Labor Agreement with International Brotherhood of Teamsters, Local 320

It was moved by Cunningham, seconded by Kramer that the Metropolitan Council authorize the Regional Administrator to enter into a labor agreement with the Teamsters Local 320, effective January 1, 2013 through December 31, 2015.

- Continuity of Operations Project (COOP) Update: Kathy Matter, offered a program update, highlighting active projects, strategies and activities, scope and timelines, next steps and challenges and risks. Vince Pellegrin and Lt. Jim Franklin presented a report of the Metro Transit Emergency Response Preparedness and Plans, highlighting training, drills and exercises required for effective Emergency Management.
- 2. Central Corridor Light Rail Transit (CCLRT) Cash Flow Quarterly Report Q4: Allen Hoppe reported the CCLRT project is on target with budget expectations; some of the 2013 federal funding could be deferred if Sequestration occurs.
- 3. Summary of Procurements for Fourth Quarter 2012: Micky Gutzmann reported Q4 2012 procurements numbered 4,503, for a total value of \$71,754,064.
- 4. Mary Bogie offered assurance that the Council is closely following federal funding action and will track internal costs if Sequestration occurs.
