#### **Proposed Action**

That the Metropolitan Council authorize the amendment of the 2013 Unified Capital Program as indicated and in accordance with the attached tables.

#### Background

This proposed amendment programs new federal, local and regional funding to capital projects in Metro Transit and Metropolitan Transportation Services in the Transportation Division.

Metro Transit is proposing to increase its Authorized Capital Program by \$4.4 million, using federal and regional funding sources. Metro Transit's proposed 2013 Capital Budget would increase by \$465,000.

Metropolitan Transportation Services is proposing to increase its Authorized Capital Program by \$19.8 million and its 2013 Capital Budget by \$905,000, using federal, local and regional funding sources.

The proposed amendment also amends the capital program for Parks and Open Space in the Community Development Division to remove completed projects from the Authorized Capital Program and provide \$1.5 million of regional funding for land acquisition opportunity grants.

### Rationale

This proposed amendment programs available federal, state, local and regional funds to capital projects that allow the Council to carry out its long-term capital improvement programs for transit and parks.

## Funding

Federal, state and local funding provide \$ 5.4 million, or 21 percent of the funding for these amendments. Regional funding for provides the remaining \$20.3, or 79 percent.

For Transit projects, there is available, unprogrammed regional bonding authority from the Legislature to accommodate the additional bonding.

### **Proposed Action**

That the Metropolitan Council amend the 2013 Capital Budget (annual appropriation) and Authorized Capital Program (multi-year authorization) as indicated and in accordance with the attached table.

### Background

This proposed amendment authorizes reallocations, reductions and increases of federal, local and regional funding for new and existing projects as detailed in **ATTACHMENT 1**.

### <u>Metro Transit</u>

### Closing Projects/Reallocate Authorized Funding:

### **Overhaul Base Paint Booth & Renovations # 64110**

This amendment adjusts RTC Federal Funding by (\$560,000) and increases Federal Funding by \$560,000 to match the actual authorized federal grant authority in the Notice of Grant Award. This project is identified in the CIP.

### **Reduce Authorized Funding:**

None.

## Increase Authorized Funding/Authorize New Projects:

### LRT Tie Replacement – Project #61316

This amendment provides \$308,000 in Federal Funds and \$77,000 in RTC Funds to replace 1,000 defective and failing concrete dual block railroad ties. This project is identified in the CIP.

### System Security \$200,000 – Projects 62223, 62224, 62225 and 69218.

This amendment provides \$200,000 in RTC Fund to impliement security equipment at various Metro Transit locations. Equipment includes card access, intrusion alarms, close circuit TV and locking systems. Projects include: \$50,000 to Project 62223 Park and Ride System Security; \$25,000 to Project 62224 LRT Station Security; \$25,000 to Project 62225 Transit Hub Security and \$100,000 to Project 69218 Garage Security Upgrades. These projects are identified in the CIP.

#### Building & Energy Enhancement – Project #62111e

This amendment provides \$800,000 in Federal Funds and \$200,000 in RTC Funds for various energy improvement and recovery projects for public and support facilities. These energy projects have an average payback of 6 years and continue Metro Transits efforts to reduce operating costs. This project is identified in the CIP.

#### Major Improvements to Support Facilities – Project #62790e

This amendment provides \$400,000 in RTC Funds to begin planned improvement projects to support facilities. Projects include: Heywood Water Main improvements, LRT Door Replacement, OHB First Floor Remodel, Ruter Concrete improvements, Ruter Bi-fold Door Replacement, and Parking Lot Repairs at multiple facilities. This project is identified in the CIP.

#### Public Facilities Refurbishment – Project #63350e

This amendment provides \$600,000 in RTC funds to be used for improvements to Metro Transit Facilities. Projects include: Woodbury Theatre Parking Lot improvements, SunRay Reconfiguration for Snow Removal, Overlay at Multiple Lots and Multiple Plaza Concrete Repairs. This project is identified in the CIP.

#### **Renewable Energy Initiatives – Project 69216e**

This amendment provides \$600,000 in Federal funds and \$150,000 in RTC funds to be used for Renewable Energy Generation at Metro Transit Facilities. Projects include: Adding Solar Panels, Wind Generation, Energy Recovery and Other Technologies to allow for onsite energy generation to reduce utility consumption to help meet agency sustainability goals. This project is identified in the CIP.

#### LRT Blue – Type 1 LRV Video Mirrors – Project NEW

This amendment provides \$320,000 in Federal Funds and \$80,000 in RTC Funds to replace regular mirrors and video mirrors on Bombardier Type 1 LRV's to operate on the Green Line. This project is identified in the CIP.

#### LRT Blue – Type 1 LRV Signage to Color LED Boards – Project NEW

This amendment provides \$240,000 in Federal Funds and \$60,000 in RTC Funds for color LED signage boards on Bombardier Type 1 LRV's to identify which LRV line the car is operating on. This project is identified in the CIP.

#### LRT Blue – Train Operator Display Screen Replacement – Project NEW

This amendment provides \$120,000 in Federal Funds and \$30,000 in RTC Funds for the train operator display screens on Bombardier Type 1 LRV's. This project is identified in the CIP.

## LRT Blue – Network Upgrade – Project NEW

This amendment provides \$200,000 in Federal Funds and \$50,000 in RTC Funds to replacement the communication network and upgrade capacity on the Blue Line. This system will handle transport of all critical control system functions, telephone lines, public announcements and CCTV feeds. This project is identified in the CIP.

## Increase Authorized Funding / Authorize New Projects:

## 2014 – MTS – Bus Procurement - CMAQ Expansion - Project #35788

This amendment authorizes an addition of \$840,000 of Counties Transit Improvement Board (CTIB) funds for the purchase of five (5) expansion buses for expanded service along I-35W South. In 2012, MTS applied for and was awarded a grant to cover 30% of the cost of these five (5) expansion vehicles. These vehicles will become part of the regional base fleet plan once purchased and will be expected to be replaced on regularly scheduled intervals. This project was identified in the CIP.

### Security Cameras – Project #35936

This amendment authorizes and additional \$65,000 in RTC funds for the purchase and installation of sixteen (16) sets of cameras into Anoka County buses. This project is identified in the CIP.

### 2015 - MVTA - Bus - Replacement - Project #35940 (New)

This amendment authorizes \$5,988,000 in RTC funds to Minnesota Valley Transit Authority (MVTA) for the purchase of twelve (12) forty-foot low floor buses to be used in the regional fleet. This amendment further authorizes the Regional Administrator to execute a grant agreement with MVTA to reimburse them for the purchase of these buses in an amount not to exceed the total project cost. This project replaces existing fleet that has met or exceeded its useful life. This project is identified in the CIP.

### 2015 - SWT - Bus - Replacement - Project #35941 (New)

This amendment authorizes \$5,988,000 in RTC funds for the purchase of twelve (12) forty-foot low floor buses for SouthWest Transit (SWT). This project replaces existing fleet that has met or exceeded its useful life. This project is identified in the CIP.

### 2015 - MTS - Bus - Replacement - Project #35942 (New)

This amendment authorizes \$5,085,600 in RTC funds for the purchase of thirteen (13) thirty-foot low floor buses for MTS. This project replaces existing fleet that has met or exceeded its useful life. This project is identified in the CIP.

### 2014 – Prior Lake – BluExpress Expansion Buses – CMAQ– Project #35943 (New)

This amendment authorizes \$1,440,444 in Congestion Mitagation and Air Quality (CMAQ) and \$360,000 in RTC funds for the purchase of three (3) expansion buses for the City of Prior Lake to operate expansion service from the city of Prior Lake to downtown Minneapolis. The costs of operating these vehicles for the first three years will be covered by CMAQ operating awarded along with the vehicles. This project is identified in the CIP.

### **Change to Current Year Expenditures**

Based on projected expenditures for the proposed amendments, the 2013 Capital Budget is proposed to be increased by \$4,435,000 and \$19,766,600 for Metro Transit and Metropolitan Transportation Services, respectively.

## Rationale

This amendment is required to close projects and authorize new funding for existing and new projects within the Transportation Division's Authorized Capital Program. These activities will allow the Council to carry out its long-term capital improvement program for transit.

## Funding

This amendment provides \$4,588,000 in Federal funds, \$840,000 in CTIB funds and \$18,773,600 in RTC funds to the Authorized Capital Program for transit projects.

#### **Proposed Action**

That the Metropolitan Council authorize the amendment of the 2013 Unified Capital Program as indicated and in accordance with the attached table.

#### Background

The proposed capital program and budget amendment includes the following changes to the adopted Parks and Open Space capital program:

#### Reducing Funding Commitments:

Forty-seven (47) grants are closed out for a total of \$18,173,744.

The balance of unobligated Acquisition Opportunity Fund grants financed from the Parks and Trails Legacy Fund Acquisition Account is adjusted by adding \$193,437 of undisbursed funds from closed out grants in that account and adding \$1.5 million of Council bonds to this account as authorized by the Council on September 25 (action item 2013-266).

The balance of unobligated Acquisition Opportunity Fund grants from the Environmental Trust Fund Acquisition Account is adjusted by adding \$32,279 of undisbursed funds from closed out grants in that account.

#### Increasing Funding Commitments:

A total of nine (9) Land Acquisition Opportunity Fund grants totaling \$6,064,631 were approved since the last capital budget amendment. Of this amount, five (5) were financed from the Parks and Trails Legacy Fund Acquisition Account were approved since the last capital budget amendment totaling \$2,730,067. The remaining four (4) grants were financed from the Environmental Trust Fund Acquisition Account totaling \$3,334,564.

#### Change in Current Year Expenditures:

There are no changes for the projected expenditures from the proposed amendment in the remainder of 2013 because all expenditures from the Land Acquisition Opportunity Fund grants are using funds previously authorized in those accounts.

The Multi-Year Authorization is decreased by \$16,673,744 based on the net results of deducting reduced funding commitments from increased funding commitments and is shown in Attachment 1 in the "Multi-Year Authorization" column on the bottom line "Parks and Open Space Total".

### Rationale

This amendment to the 2013 Authorized Capital Program acknowledges closed out grants, adjusts the balance of unobligated funds for Land Acquisition Opportunity Fund grants and acknowledges Land Acquisition Opportunity Fund grants previously authorized by Council actions.

## Funding

The amendment is financed with the State appropriations and Metropolitan Council bonds as shown in Attachment 1.

## Known Support / Opposition

The grants are consistent with legislative and Metropolitan Council policies/requirements. There is no known opposition to the amendment. The Metropolitan Parks and Open Space Commission will be informed about this amendment at their November meeting.
