## **Proposed Action**

That the Metropolitan Council authorize the amendment of the 2014 Unified Budget as indicated and in accordance with the attached tables.

## **Background**

This proposed capital program amendment programs local funding of \$45 million from the Counties Transportation Improvements Board (CTIB) and the Hennepin County Regional Rail Authority (HCRRA) for the Blue Line Extension/Bottineau LRT Project for the two year project development stage and increases the spending authority for the project. CTIB is providing \$27.6 million and HCRRA \$17.4 million in funding for the amendment. The proposed amendment also provides additional regional funding to a Metropolitan Transportation Services (MTS) bus procurement project.

#### Rationale

The proposed amendment programs available local and regional funds to the capital program to allow the Council to carry out its work plan and its long-term capital improvement programs for transit.

## **Funding**

The capital amendment is funded with new local and regional funding. Regional funding is available within existing regional bonding authority.

## **Fiscal Impact**

### **Cash Flow**

This amendment adds \$45 million in authorized expenditures to the Bottineau/Blue Line Extension project funded entirely with Local Revenues. \$2,623,707 will be spent in 2014. The MTS amendment will increase spending by \$430,000 in 2014 funded with regional transit bonding authority. The 2014 Capital Budget for the Transportation Division increases by \$3,053,707.

## **Impact on Regional Taxpayers**

The proposed amendment utilizes \$430,000 of existing regional transit bonding authority and is paid for through the Council's Transit Debt Service Levy.

## **Proposed Action**

That the Metropolitan Council amend the 2014 Unified Budget - Capital Program (annual appropriation) and Authorized Capital Program (multi-year authorization) as indicated and in accordance with the attached table, Capital – Attachment #1.

## **Background**

This proposed amendment authorizes an increase in local funding of \$45,000,000 from CTIB and HCRRA for the Blue Line Extension LRT Project for the two year Project Development phase. The current authorization in this project includes \$1,000,000 in State GO Bonds provided by the 2014 Legislature which will also be used for the Project Development phase for a total of \$46,000,000 in Project Development. These funds represent a portion of their respective funding commitments and will be a match to the future federal FFGA grant.

The Council previously authorized \$150,000 in HCRRA funding to be utilized for Pre-Project Development expenditures which will not be used as a match to the future federal FFGA grant. Pre-Project Development expenditures have totaled \$23,707 leaving a remaining authorization balance of \$126,293. This amount will not be needed for future expenditures and the remaining authorization will be removed.

#### Bottineau LRT - Project #69304

This amendment reclassifies the \$1,000,000 in State GO Bonds provided by the 2014 Legislature for the Bottineau LRT to a new project called Bottineau LRT Blue Line Extension. These funds will be used as a match to the future federal FFGA grant. This amendment also removes the remaining Pre-Project Development authorization of \$126,293 of HCRRA funds not needed for future expenditures. This project is identified in the CIP.

## Bottineau LRT - Blue Line Extension - Project New

This amendment provides \$45,000,000 million in local funds for Blue Line Extension Project Development; \$27.6 million from CTIB and \$17.4 million from HCRRA. CTIB and HCRRA committed these funds contingent upon FTA's approval of the project to enter Project Development, which was received on August 22, 2014. This amendment also provides \$1,000,000 in State GO Bonds provided by the 2014 Legislature for the Bottineau LRT project. These funds will be used for the Project Development phase for a total of \$46,000,000. This project is identified in the CIP.

## 2014 - MTS - Bus Replacement - Project #35912

This amendment authorizes an additional \$430,000 in RTC funding for the purchase of sixteen (16) 30-foot vehicles. These vehicles have reached the end of their useful. This project is identified in the CIP.

#### **Change to Current Year Expenditures**

Based on projected expenditures for the proposed amendments, the 2014 Capital Budget is proposed to be increased by \$2,623,707 and \$430,000 for Metro Transit and MTS, respectively.

#### Rationale

This amendment is required to authorize the transfer of funds between projects and new funding for existing and new projects within the Transportation Division's Authorized Capital Program. These activities will allow the Council to carry out its long-term capital improvement program for transit.

#### **Funding**

This amendment provides \$44,873,707 in other funds and \$430,000 in RTC for the Authorized Capital Program.
