Background

On August 13, 2012, the Council approved Business Item 2012-256 authorizing the Regional Administrator to submit grant applications to CTIB for 2013 funding. On October 10, 2012, the Council approved Business Item 2012-304 stating these grant applications are consistent with the adopted 2030 Transportation Policy Plan. This proposed action will allow agreements to be executed with CTIB to accept the grant awards.

The Council also submitted a \$2.4 million CTIB capital application for the Bottineau Transitway project. However, because the Council has not yet developed the cost and schedule detail for the Bottineau project, the Hennepin County Regional Railroad Authority (HCRRA) subsequently submitted a \$2.4 million Bottineau grant application to CTIB with a \$1.6 million county local match. In approving the grant, CTIB noted the intent for the HCRRA to subgrant the total \$4 million to the Council for preliminary engineering and environmental work.

For Southwest LRT, the CTIB funding from prior year grant awards is anticipated to be sufficient to cover CTIB's portion of the forecasted expenses for 2013 so a new grant award for 2013 is not needed. At the request of the Council, CTIB has committed to fund up to 60% of the total



cost of the preliminary engineering phase going forward, for an amount not to exceed \$55.8 million.

Rationale

CTIB operating grant funds will provide 75% of the net cost of transitway operations for January through June and 50% for July through December, 2013. The I-35W South BRT capital grant will fund buses for expanded express service in the corridor.

Funding

The CTIB funding is included as part of the adopted 2013 operating and capital budgets. Therefore, no budget amendments are necessary.
