#### **Proposed Action**

That the Metropolitan Council adopts the attached Transit Oriented Development Policy (TOD Policy) to guide activities across the organization that advance TOD.

#### Background

The TOD Strategic Action Plan, adopted by the Council on July 10, 2013, recommended that the Council immediately pursue the adoption of a TOD Policy. To that end, the attached Policy identifies four TOD goals that the Council will advance through its programs, investments, assets and staff. Additionally, it identifies five key strategies that the Council will undertake to advance these goals. Finally, the TOD Policy outlines its purpose, background, and modes of implementation.

This policy serves several purposes:

- To coordinate and align the Council's TOD-related activities
- To communicate the Council's vision and goals for TOD with partners
- To support funding applications for future transitways

The TOD Policy was developed through a collaborative process over the course of nearly two years. During this time, Council leadership, staff, and consultants have held discussions with hundreds of partners and stakeholders to inform the Policy. The TOD policy was also informed by best practices from other regions. Furthermore, it was developed in alignment with the Council's forthcoming Thrive MSP 2040 regional plan and the 2040 Transportation Policy Plan. The Policy was also influenced by ongoing regional efforts such as Corridors of Opportunity.

#### Rationale

The TOD Policy provides a framework for the Council to play a leadership role across sectors and political boundaries in the planning and implementation of TOD throughout the region. The Council, as the regional planning agency and transit provider, has an important stake in maximizing TOD potential along existing and proposed transit corridors. TOD is an important tool to advance the Council's mission and vision. Specifically, through TOD the Council will advance the following goals:

- Maximize the development impact of transit investments by integrating transportation, jobs and housing
- Support regional economic competitiveness by leveraging private investment
- Advance equity by improving multimodal access to opportunity for all

• Support a 21<sup>st</sup> century transportation system through increased ridership and revenues

## **Known Support / Opposition**

Through the TOD Strategic Action Plan and subsequent discussions, partners have expressed broad support for this approach.
