RESOLUTION 2013-35

TO ISSUE AND SELL GENERAL OBLIGATION TRANSIT NOTES, SERIES 2014C, FIXING THE FORM AND SPECIFICATIONS THEREOF, PROVIDING FOR THEIR EXECUTION AND DELIVERY AND LEVYING TAXES FOR THEIR PAYMENT

BE IT RESOLVED by the Metropolitan Council (the "Council" or the "Issuer"), as follows:

SECTION 1. AUTHORIZATION AND SALE.

- 1.1 <u>Authorization and Purpose</u>. This Council determines that it is necessary to sell and issue its General Obligation Transit Notes, Series 2014C (the "Notes"), in an aggregate principal amount not to exceed \$25,000,000, subject to adjustment as provided in the Terms of Proposal referred to in Section 1.2 hereof, pursuant to Minnesota Statutes, Section 473.39 and Chapter 475, to finance capital expenditures as prescribed in the Council's regional transit master plan and transit capital improvement program (the "Improvements").
- 1.2 Terms of Note Sale; Notices. The Council has retained Springsted Incorporated, St. Paul, Minnesota ("Springsted") as independent financial advisor, and, pursuant to Minnesota Statutes, Section 475.60, subdivision 2, paragraph 9, Springsted is hereby authorized to solicit proposals for the Notes on behalf of the Council on a competitive basis without requirement of published notice. The terms of the Notes and the sale thereof shall be substantially as set forth in the Terms of Proposal attached as Exhibit A hereto, which is hereby approved. The Council hereby determines to sell the Notes in accordance with the procedures set forth in Exhibit A. The specifications set forth in Exhibit A may be revised by the Chief Financial Officer in consultation with Springsted, provided that the principal amount of Notes authorized and issued hereunder shall not exceed \$25,000,000. The Council hereby delegates to the Chief Financial Officer, or the Chief Financial Officer's designee, authority to consider the proposals and award the sale not later than 90 days from the date hereof based upon the best proposal, provided that the true interest cost of the Notes shall not exceed a 1.10% per annum and the purchase price must be not less than the par amount of the Notes.

SECTION 2. NOTE TERMS; REGISTRATION; EXECUTION AND DELIVERY

2.1 <u>Maturities; Interest Rates; Denominations and Payment.</u> The Notes shall be originally dated as of the date of issuance, shall be in the denomination of \$5,000 each, or any integral multiple thereof, shall mature on March 1 in the respective years and amounts stated in the Terms of Proposal, and shall bear interest from date of issue until paid at the respective annual rates established pursuant to Section 1.2 hereof.

The Notes shall be issuable only in fully registered form. The interest thereon and, upon surrender of each Note, the principal amount thereof shall be payable by wire transfer, check or draft issued by the Registrar described herein; provided that, so long as the Notes are registered in the name of a securities depository, or a nominee thereof, in accordance with Section 2.6, principal and interest shall be payable in accordance with the operational arrangements of the securities depository.

- 2.2 <u>Dates and Interest Payment Dates</u>. Upon initial delivery of the Notes pursuant to Section 2.7 hereof, and upon any subsequent transfer or exchange pursuant to Section 2.5, the date of authentication shall be noted on each Note so delivered, exchanged or transferred. Interest on the Notes shall be payable on March 1 and September 1 in each year, commencing September 1, 2014, to the owner of record thereof as of the close of business on the fifteenth day of the immediately preceding month, whether or not such day is a business day.
- 2.3 <u>Redemption</u>. Prospective proposers may designate any portion of the principal of the Notes to be combined within one or more term Notes subject to mandatory sinking fund redemption. The Notes will not be subject to optional redemption and prepayment prior to their stated maturity dates.
- 2.4 Appointment of Initial Registrar. The Issuer hereby appoints the Chief Financial Officer of the Council, in St. Paul, Minnesota, as the initial note registrar, transfer agent and paying agent (the "Registrar"). The Issuer reserves the right to change the Registrar upon thirty (30) days notice and upon the appointment of a successor Registrar, in which event the predecessor Registrar shall deliver all cash and Notes in its possession to the successor Registrar and shall deliver the register to the successor Registrar.
- 2.5 <u>Registration</u>. The effect of registration and the rights and duties of the Issuer and the Registrar with respect thereto are as follows:
- (a) <u>Register</u>. The Registrar shall keep at its office a note register in which the Registrar shall provide for the registration of ownership of Notes and the registration of transfers and exchanges of Notes entitled to be registered, transferred or exchanged.
- (b) <u>Transfer of Notes</u>. Upon surrender for transfer of any Note duly endorsed by the registered owner thereof or accompanied by a written instrument of transfer, in form satisfactory to the Registrar, duly executed by the registered owner thereof or by an attorney duly authorized by the registered owner in writing, the Registrar shall authenticate and deliver, in the name of the designated transferee or transferees, one or more new Notes, aggregate principal amount and maturity, as requested by the transferor. The Registrar may, however, close the books for registration of any transfer after the fifteenth day of the month preceding each interest payment date and until such interest payment date.
- (c) <u>Exchange of Notes</u>. Whenever any Notes are surrendered by the registered owner for exchange the Registrar shall authenticate and deliver one or more new Notes, aggregate principal amount and maturity, as requested by the registered owner or the owner's attorney in writing.
- (d) <u>Cancellation</u>. All Notes surrendered upon any transfer or exchange shall be promptly canceled by the Registrar and thereafter disposed of as directed by the Issuer.
- (e) <u>Improper or Unauthorized Transfer</u>. When any Note is presented to the Registrar for transfer, the Registrar may refuse to transfer the same until it is satisfied that the endorsement on such Note or separate instrument of transfer is valid and genuine and that the requested transfer is legally authorized. The Registrar shall incur no liability for the refusal, in good faith, to make transfers which it, in its judgment, deems improper or unauthorized.

- (f) Persons Deemed Owners. The Issuer and the Registrar may treat the person in whose name any Note is at any time registered in the note register as the absolute owner of such Note, whether such Note shall be overdue or not, for the purpose of receiving payment of, or on account of, the principal of and interest on such Note and for all other purposes, and all such payments so made to any such registered owner or upon the owner's order shall be valid and effectual to satisfy and discharge the liability upon such Note to the extent of the sum or sums so paid.
- (g) <u>Taxes, Fees and Charges</u>. For every transfer or exchange of Notes, the Registrar may impose a charge upon the owner thereof sufficient to reimburse the Registrar for any tax, fee or other governmental charge required to be paid with respect to such transfer or exchange.
- (h) Mutilated, Lost, Stolen or Destroyed Notes. In case any Note shall become mutilated or be destroyed, stolen or lost, the Registrar shall deliver a new Note, amount, number, maturity date and tenor in exchange and substitution for and upon cancellation of any such mutilated Note or in lieu of and in substitution for any such Note destroyed, stolen or lost, upon the payment of the reasonable expenses and charges of the Registrar in connection therewith; and, in the case of a Note destroyed, stolen or lost, upon filing with the Registrar of evidence satisfactory to it that such Note was destroyed, stolen or lost, and of the ownership thereof, and upon furnishing to the Registrar of an appropriate note or indemnity in form, substance and amount satisfactory to it, in which both the Issuer and the Registrar shall be named as obligees. All Notes so surrendered to the Registrar shall be canceled by it and evidence of such cancellation shall be given to the Issuer. If the mutilated, destroyed, stolen or lost Note has already matured or been called for redemption in accordance with its terms it shall not be necessary to issue a new Note prior to payment.
- (i) <u>Authenticating Agent</u>. The Registrar is hereby designated authenticating agent for the Notes, within the meaning of Minnesota Statutes, Section 475.55, Subdivision 1, as amended.

2.6 Securities Depository.

(a) For purposes of this Section 2.6, the following terms shall have the following meanings:

"Beneficial Owner" shall mean, whenever used with respect to a Note, the person in whose name such Note is recorded as the beneficial owner of such Note by a Participant on the records of such Participant, or such person's subrogee.

"Cede & Co." shall mean Cede & Co., the nominee of DTC, and any successor nominee of DTC with respect to the Notes.

"DTC" shall mean The Depository Trust Company of New York, New York.

"Participant" shall mean any broker-dealer, bank or other financial institution for which DTC holds Notes as securities depository.

"Representation Letter" shall mean the Representation Letter pursuant to which the sender agrees to comply with DTC's Operational Arrangements.

- The Notes shall be initially issued as separately authenticated fully registered notes, and one Note shall be issued in the principal amount of each stated maturity of the Notes. Upon initial issuance, the ownership of such Notes shall be registered in the note register in the name of Cede & Co., as nominee of DTC. The Registrar and the Issuer may treat DTC (or its nominee) as the sole and exclusive owner of the Notes registered in its name for the purposes of payment of the principal of or interest on the Notes, selecting the Notes or portions thereof to be redeemed, if any, giving any notice permitted or required to be given to registered owners of Notes under the Resolution, registering the transfer of Notes, and for all other purposes whatsoever; and neither the Registrar nor the Issuer shall be affected by any notice to the contrary. Neither the Registrar nor the Issuer shall have any responsibility or obligation to any Participant, any person claiming a beneficial ownership interest in the Notes under or through DTC or any Participant, or any other person which is not shown on the note register as being a registered owner of any Notes, with respect to the accuracy of any records maintained by DTC or any Participant, with respect to the payment by DTC or any Participant of any amount with respect to the principal of or interest on the Notes, with respect to any notice which is permitted or required to be given to owners of Notes under the Resolution, with respect to the selection by DTC or any Participant of any person to receive payment in the event of a partial redemption of the Notes, or with respect to any consent given or other action taken by DTC as registered owner of the Notes. So long as any Note is registered in the name of Cede & Co., as nominee of DTC, the Registrar shall pay all principal of and interest on such Note, and shall give all notices with respect to such Note, only to Cede & Co. in accordance with DTC's Operational Arrangements, and all such payments shall be valid and effective to fully satisfy and discharge the Issuer's obligations with respect to the principal of and interest on the Notes to the extent of the sum or sums so paid. No person other than DTC shall receive an authenticated Note for each separate stated maturity evidencing the obligation of the Issuer to make payments of principal and interest. Upon delivery by DTC to the Registrar of written notice to the effect that DTC has determined to substitute a new nominee in place of Cede & Co., the Notes will be transferable to such new nominee in accordance with paragraph (e) hereof.
- (c) In the event the Issuer determines that it is in the best interest of the Beneficial Owners that they be able to obtain Notes in the form of note certificates, the Issuer may notify DTC and the Registrar, whereupon DTC shall notify the Participants of the availability through DTC of Notes in the form of certificates. In such event, the Notes will be transferable in accordance with paragraph (e) hereof. DTC may determine to discontinue providing its services with respect to the Notes at any time by giving notice to the Issuer and the Registrar and discharging its responsibilities with respect thereto under applicable law. In such event the Notes will be transferable in accordance with paragraph (e) hereof.
- (d) The execution and delivery of the Representation Letter to DTC, if not previously filed with DTC, by the Chair or Treasurer is hereby authorized and directed.
- (e) In the event that any transfer or exchange of Notes is permitted under paragraph (b) or (c) hereof, such transfer or exchange shall be accomplished upon receipt by the Registrar of the Notes to be transferred or exchanged and appropriate instruments of transfer to the permitted transferee in accordance with the provisions of the Resolution. In the event Notes in the form of certificates are issued to owners other than Cede & Co., its successor as nominee for DTC as owner of all the Notes, or another securities depository as owner of all the Notes, the provisions of the Resolution shall also apply to all matters relating thereto, including, without

limitation, the printing of such Notes in the form of note certificates and the method of payment of principal of and interest on such Notes in the form of note certificates.

- Execution, Authentication and Delivery. The Notes shall be executed on behalf of the Issuer by the signatures of the Chair and the Treasurer, provided that the signatures may be printed, engraved or lithographed facsimiles of the originals. In case any officer whose signature or a facsimile of whose signature shall appear on the Notes shall cease to be such officer before the delivery of any Note, such signature or facsimile shall nevertheless be valid and sufficient for all purposes, the same as if such officer had remained in office until delivery. Notwithstanding such execution, no Note shall be valid or obligatory for any purpose or entitled to any security or benefit under this Resolution unless and until a certificate of authentication on the Note has been duly executed by the manual signature of the Registrar. The executed certificate of authentication on each Note shall be conclusive evidence that it has been authenticated and When the Notes have been prepared, executed and delivered under this Resolution. authenticated, the Notes shall be delivered to the purchaser thereof (a "Purchaser") upon payment of the purchase price in accordance with the contract of sale hereinafter executed therefor, and such Purchaser shall not be obligated to see to the application of the purchase price.
- 2.8 <u>Form of Notes</u>. The Notes, the Registrar's Authentication Certificate, and the form of assignment shall be prepared in substantially the forms set forth in <u>Exhibit C</u> hereto.
- SECTION 3. <u>USE OF PROCEEDS</u>. Upon payment for the Notes by the Purchaser thereof, the Chief Financial Officer shall deposit any accrued interest and any premium received on the sale of the Notes, directly in the Note Fund established pursuant to Section 4 hereof and shall deposit the remaining proceeds of the Notes into a separate Transit Note Proceeds Fund (the "Proceeds Fund"). Note proceeds deposited in the Proceeds Fund and investment income thereon shall be disbursed at the direction of the Council for the Improvements, including the costs of issuance of the Notes and payment of interest on the Notes prior to completion of such purposes. Any moneys remaining in the Proceeds Fund after payment of all costs financed by the Notes shall be transferred to the Note Fund and used to pay principal and interest coming due on the Notes.
- SECTION 4. TRANSIT NOTE FUND. The Notes issued pursuant to this Resolution shall be payable from a separate and special Transit Note Fund (the "Note Fund") of the Issuer, which the Issuer agrees to maintain until the Notes have been paid in full. There is hereby appropriated and shall be paid into the Note Fund, Note proceeds to the extent provided in Section 3 hereof, all taxes collected pursuant to Sections 5 and 6 hereof, any other funds appropriated by the Council for the payment of the Notes, and all investment income on the foregoing. The moneys on hand in the Note Fund from time to time shall be used only to pay the principal of and interest on the Notes when due. If the money in the Note Fund should at any time be insufficient to pay principal and interest due on such Notes, such amounts shall be paid from other moneys on hand in other funds of the Issuer, which other funds shall be reimbursed therefor when sufficient money becomes available in the Note Fund.
- SECTION 5. <u>TAX LEVY</u>. For payment of the principal of and interest on the Notes, there is hereby levied on all taxable property in the metropolitan area as provided in Minnesota Statutes, Sections 473.39 and 473.446, a transit tax, collectible in the years and amounts equal to an amount which is not less than 5% in excess of the principal of and interest on the Notes due in each year. Such tax shall be apportioned among the counties in the metropolitan area by the

various County Auditors in accordance with state law. The proceeds of the tax, when received, shall be deposited in the Note Fund. The Council reserves the right to reduce or cancel such tax levy in accordance with Minnesota Statutes, Section 475.61.

SECTION 6. GENERAL OBLIGATION PLEDGE. The full faith, credit and unlimited taxing powers of the Council shall be and are hereby irrevocably pledged for the prompt and full payment of the principal of and interest on the Notes issued hereunder as such payments respectively become due, and the Council covenants and agrees that if and to the extent necessary for the Notes, it will levy on all taxable property in the metropolitan area that is subject to taxation by the Council, a direct, irrepealable ad valorem tax for this purpose, the collections of which shall be deposited in the Note Fund.

SECTION 7. <u>DEFEASANCE</u>. When all of the Notes issued hereunder have been discharged as provided in this section, all pledges, covenants and other rights granted by this resolution to the registered owners of the Notes shall cease. The Issuer may discharge its obligations with respect to any Notes which are due on any date by depositing with the Registrar on or before that date a sum sufficient for the payment thereof in full; or, if any Note should not be paid when due, it may nevertheless be discharged by depositing with the Registrar a sum sufficient for the payment thereof in full with interest accrued from the due date to the date of such deposit. The Issuer may also at any time discharge its obligations with respect to any Notes, subject to the provisions of law now or hereafter authorizing and regulating such action, by depositing irrevocably in escrow, with a bank qualified by law as an escrow agent for this purpose, cash or securities which are authorized by law to be so deposited, bearing interest payable at such time and at such rates and maturing or callable at the holder's option on such dates as shall be required to pay all principal and interest to become due thereon to maturity.

SECTION 8. CERTIFICATION OF PROCEEDINGS.

- 8.1 <u>Registration of Notes and Certification as to Tax Levy</u>. The Chief Financial Officer is hereby authorized and directed to file a certified copy of this resolution and such additional certificates as may be required with the County Auditors of Anoka, Carver, Dakota, Hennepin, Ramsey, Scott and Washington Counties and to obtain from each County Auditor a certificate, prepared in substantially the form set forth in <u>Exhibit D</u> hereto, that the Notes have been duly entered upon the Auditor's register and that any tax required for the payment thereof has been levied.
- 8.2 <u>Authentication of Transcript.</u> The officers of the Issuer and County Auditors of the Counties specified in Section 8.1 are hereby authorized and directed to prepare and furnish to the Purchaser and to Kennedy & Graven, Chartered, Bond Counsel, certified copies of all proceedings and records relating to the Notes and such other affidavits, certificates and information as may be required to show the facts relating to the legality and marketability of the Notes, as the same appear from the books and records in their custody and control or as otherwise known to them, and all such certified copies, affidavits and certificates, including any heretofore furnished, shall be deemed representations of the Issuer as to the correctness of all statements contained therein.
- 8.3 <u>Official Statement</u>. The Council staff, in cooperation with Springsted, is hereby authorized and directed to prepare on behalf of the Council an official statement (the "Official

Statement") to be distributed to potential purchasers of the Notes. The Official Statement shall contain the Terms of Proposal for the Notes, as set forth in Exhibit A hereto, and such other information as shall be deemed advisable and necessary to describe adequately the Issuer, the Notes and the security for, and terms and conditions thereof. The final Official Statement shall be in the form approved by the Chief Financial Officer.

SECTION 9. <u>TAX COVENANTS; ARBITRAGE MATTERS AND CONTINUING DISCLOSURE.</u>

- 9.1 <u>No Designation as Qualified Tax-Exempt Obligations</u>. The Notes are not designated as "qualified tax-exempt obligations" for purposes of Section 265(b)(3) of the Code.
- 9.2 <u>Tax Covenants</u>. (a) The Issuer covenants and agrees with the registered owners of the Notes that it will not take, or permit to be taken by any of its officers, employees or agents, any action which would cause the interest payable on the Notes to become subject to taxation under the Code and applicable Treasury Regulations (the "Regulations"), and covenants to take any and all actions within its powers to ensure that the interest on the Notes will not become includable in gross income of the recipient under the Code and the Regulations.
- (b) The Improvements financed with the proceeds of the Notes authorized by this Resolution will be owned and maintained by the Issuer so long as the Notes are outstanding and will be publicly available. The Issuer will not enter into any lease, use agreement, management agreement or other agreement or contract with any non-governmental person relating to the use of the improvements which might cause the Notes to be considered "private activity bonds" or "private loan bonds" pursuant to Section 141 of the Code.
- 9.3 <u>Arbitrage Certification</u>. The Regional Administrator and Treasurer are authorized and directed to execute and deliver to each Purchaser a certificate in accordance with the provisions of Section 148 of the Code, and Section 1.148-2(b) of the Regulations, stating the facts, estimates and circumstances in existence on the date of issue and delivery of the Notes which make it reasonable to expect that the proceeds of the Notes will not be used in a manner that would cause the Notes to be arbitrage bonds within the meaning of the Code and Regulations.
- 9.4 <u>Arbitrage Rebate</u>. The Issuer acknowledges that the Notes are subject to the rebate requirements of Section 148(f) of the Code. The Issuer covenants and agrees to retain such records, make such determinations, file such reports and documents and pay such amounts at such times as are required under said Section 148(f) and applicable Regulations to preserve the exclusion of interest on the Notes from gross income for federal income tax purposes, unless the Notes qualify for an exception from the rebate requirement pursuant to one of the spending exceptions set forth in Section 1.148-7 of the Regulations and no "gross proceeds" of the Notes (other than amounts constituting a "bona fide debt service fund") arise during or after the expenditure of the original proceeds thereof.
- 9.5 <u>Continuing Disclosure</u>. To provide for the public availability of certain information relating to the Notes and the security therefor and to permit the original Purchaser and other participating underwriters in the primary offering of the Notes to comply with amendments to Rule 15c2-12 promulgated by the Securities and Exchange Commission under

the Securities Exchange Act of 1934 (17 C.F.R. § 240.15c2-12), relating to continuing disclosure (as in effect and interpreted from time to time, the "Rule"), which will enhance the marketability of the Notes, the Issuer hereby makes the covenants and agreements in Exhibit B hereto for the benefit of the Owners (as defined in Exhibit B) from time to time of the outstanding Notes. The Chief Financial Officer shall have overall responsibility for compliance with the Undertaking of Continuing Disclosure and other similar undertakings hereafter made by the Council under Rule 15c2-12(b)(5), and the Chief Financial Officer shall implement the dissemination of reports and notices thereunder. Amendments permitted by the undertakings necessitated by a change in circumstances that arises from a change in legal requirements, or change in law may be made by the Chief Financial Officer.

SECTION 10. <u>RATINGS</u>. The Chief Financial Officer or the Chief Financial Officer's designee, is authorized and directed to obtain ratings of the Notes from up to three nationally recognized credit rating services, to pay the reasonable and customary charges of such rating services, and to take such other action as may be required so that the Notes may be issued and sold as contemplated hereby.

SECTION 11. <u>SEVERABILITY</u>. If any section, paragraph or provision of this resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this resolution.

SECTION 12. <u>HEADINGS</u>. Headings in this resolution are included for convenience of reference only and are not a part hereof, and shall not limit or define the meaning of any provision hereof.

DETAILS OF THE SERIES 2014C NOTES

The Series 2014C Notes will be dated as of the date of delivery, as the date of original issue, and will bear interest payable on March 1 and September 1 of each year, commencing September 1, 2014. Interest will be computed on the basis of a 360-day year of twelve 30-day months.

The Series 2014C Notes will mature March 1 in the years and amounts* as follows:

* The Council reserves the right, after proposals are opened and prior to award, to increase or reduce the principal amount of the Series 2014C Notes or the amount of any maturity in multiples of \$5,000. Any Deposit made by the successful bidder by check or wire transfer will be delivered to the Council following the award of the Series 2014C Notes. A description of this undertaking is set forth in the Official Statement. The purchaser's obligation to purchase the Series 2014C Notes will be conditioned upon receiving evidence of this undertaking at or prior to delivery of the Series 2014C Notes.

OFFICIAL STATEMENT

The Council has authorized the preparation of an Official Statement containing pertinent information relative to the Series 2014C Notes, and said Official Statement will serve as a nearly final Official Statement within the meaning of Rule 15c2-12 of the Securities and Exchange Commission. For copies of the Official Statement or for any additional information prior to sale, any prospective purchaser is referred to the Financial Advisor to the Council, Springsted Incorporated, 380 Jackson Street, Suite 300, Saint Paul, Minnesota 55101, telephone (651) 223-3000.

The Official Statement, when further supplemented by an addendum or addenda specifying the maturity dates, principal amounts and interest rates of the Series 2014C Notes, together with any other information required by law, shall constitute a "Final Official Statement" of the Council with respect to the Series 2014C Notes, as that term is defined in Rule 15c2-12. By awarding the Series 2014C Notes to any underwriter or underwriting syndicate submitting a proposal therefor, the Council agrees that, no more than seven business days after the date of such award, it shall provide without cost to the senior managing underwriter of the syndicate to which the Series 2014C Notes are awarded up to 25 copies of the Official Statement and the addendum or addenda described above. The Council designates the senior managing underwriter of the syndicate to which the Series 2014C Notes are awarded as its agent for purposes of distributing copies of the

Final Official Statement to each Participating Underwriter. The Issuer has complied in all material respects with any undertaking previously entered into by it under the Rule. If the Issuer fails to comply with any provisions of this section, any person aggrieved thereby, including the Owners of any outstanding Notes, may take whatever action at law or in equity may appear necessary or appropriate to enforce performance and observance of any agreement or covenant contained in this section, including an action for a writ of mandamus or specific performance. Direct, indirect, consequential and punitive damages shall not be recoverable for any default hereunder to the extent permitted by law. Notwithstanding anything to the contrary contained herein, in no event shall a default under this section constitute a default under the Notes or under any other provision of this resolution. As used in this section, "Owner" means, in respect of a Note, the registered owner or owners thereof appearing in the register maintained by the Registrar or any "Beneficial Owner" (as hereinafter defined) thereof, if such Beneficial Owner provides to the Registrar evidence of such beneficial ownership in form and substance reasonably satisfactory to the Registrar. As used herein, "Beneficial Owner" means, in respect of a Note, any person or entity which (i) has the power, directly or indirectly, to vote or consent with respect to, or to dispose of ownership of, such Note (including persons or entities holding Notes through nominees, depositories or other intermediaries), or (ii) is treated as the owner of the Note for federal income tax purposes.
- (b) <u>Information To Be Disclosed</u>. The Issuer will provide, in the manner set forth in subsection (c) hereof, either directly or indirectly through an agent designated by the Issuer, the following information at the following times:
 - (1) Within 9 months after the end of each fiscal year of the Issuer, commencing with the fiscal year ending December 31, 2013, the following financial information and operating data in respect of the Issuer (the Disclosure Information):
 - (A) the audited financial statements of the Issuer for such fiscal year, accompanied by the audit report and opinion of the accountant or government auditor relating thereto, as permitted or required by the laws of the State of Minnesota, containing balance sheets as of the end of such fiscal year and a statement of operations, changes in fund balances and cash flows for the fiscal year then ended, showing in comparative form such figures for the preceding

fiscal year of the Issuer, prepared in accordance with generally accepted accounting principles promulgated by the Governmental Accounting Standards Board or as otherwise provided under Minnesota law, as in effect from time to time, or, if and to the extent such financial statements have not been prepared in accordance with such generally accepted accounting principles for reasons beyond the reasonable control of the Issuer, noting the discrepancies therefrom and the effect thereof, and certified as to accuracy and completeness in all material respects by the fiscal officer of the Issuer; and

(B) to the extent not included in the financial statements referred to in paragraph (A) hereof, the information for such fiscal year or for the period most recently available of the type contained in the Official Statement under headings: "Indebtedness of the Council and Its Agencies," "Council Property Values" and "Council Financial Information," which information may be unaudited.

Notwithstanding the foregoing paragraph, if the audited financial statements are not available by the date specified, the Issuer shall provide on or before such date unaudited financial statements in the format required for the audited financial statements as part of the Disclosure Information and, within 10 days after the receipt thereof, the Issuer shall provide the audited financial statements. Any or all of the Disclosure Information may be incorporated by reference, if it is updated as required hereby, from other documents, including official statements, that have been filed with the SEC or have been made available to the public on the Internet Web site of the Municipal Securities Rulemaking Board (the MSRB). The Issuer shall clearly identify in the Disclosure Information each document so incorporated by reference. If any part of the Disclosure Information can no longer be generated because the operations of the Issuer have materially changed or been discontinued, such Disclosure Information need no longer be provided if the Issuer includes in the Disclosure Information a statement to such effect; provided, however, if such operations have been replaced by other Issuer operations in respect of which data is not included in the Disclosure Information and the Issuer determines that certain specified data regarding such replacement operations would be a Material Fact (as defined in paragraph (3) hereof), then, from and after such determination, the Disclosure Information shall include such additional specified data regarding the replacement operations. If the Disclosure Information is changed or this section is amended as permitted by this paragraph (b)(1), then the Issuer shall include in the next Disclosure Information to be delivered hereunder, to the extent necessary, an explanation of the reasons for the amendment and the effect of any change in the type of financial information or operating data provided.

- (2) In a timely manner not in excess of ten business days after the occurrence of the event, notice of the occurrence of any of the following events (each a "Material Fact"):
 - (A) Principal and interest payment delinquencies;
 - (B) Non-payment related defaults, if material;

- (C) Unscheduled draws on debt service reserves reflecting financial difficulties:
- (D) Unscheduled draws on credit enhancements reflecting financial difficulties;
- (E) Substitution of credit or liquidity providers, or their failure to perform;
- (F) Adverse tax opinions, the issuance by the Internal Revenue Service of proposed or final determinations of taxability, Notices of Proposed Issue (IRS Form 5701-TEB) or other material notices or determinations with respect to the tax status of the security, or other material events affecting the tax status of the security;
 - (G) Modifications to rights of security holders, if material;
 - (H) Note calls, if material, and tender offers:
 - (I) Defeasances;
- (J) Release, substitution, or sale of property securing repayment of the securities, if material; and

 - (C) the termination of the obligations of the Issuer under this section pursuant to subsection (d);
 - (D) any change in the accounting principles pursuant to which the financial statements constituting a portion of the Disclosure Information or the audited financial statements, if any, furnished pursuant to subsection (b)(2) or (3) are prepared; and
 - (E) any change in the fiscal year of the Issuer.

(c) Manner of Disclosure.

- (1) The covenants of the Issuer in this section shall remain in effect so long as any Notes are outstanding. Notwithstanding the preceding sentence, however, the obligations of the Issuer under this section shall terminate and be without further effect as of any date on which the Issuer delivers to the Registrar an opinion of Issuer's current Bond Counsel to the effect that, because of legislative action or final judicial or administrative actions or proceedings, the failure of the Issuer to comply with the requirements of this section will not cause participating underwriters in the primary offering of the Notes to be in violation of the Rule or other applicable requirements of the Securities Exchange Act of 1934, as amended, or any statutes or laws successory thereto or amendatory thereof.
- This section (and the form and requirements of the Disclosure (2) Information) may be amended or supplemented by the Issuer from time to time, without notice to (except as provided in paragraph (c)(3) hereof) or the consent of the Owners of any Notes, by a resolution of this Council filed in the office of the recording officer of the Issuer accompanied by an opinion of Issuer's current Bond Counsel, who may rely on certificates of the Issuer and others and the opinion may be subject to customary qualifications, to the effect that: (i) such amendment or supplement (a) is made in connection with a change in circumstances that arises from a change in law or regulation or a change in the identity, nature or status of the Issuer or the type of operations conducted by the Issuer, or (b) is required by, or better complies with, the provisions of paragraph (b)(5) of the Rule; (ii) this section as so amended or supplemented would have complied with the requirements of paragraph (b)(5) of the Rule at the time of the primary offering of the Notes, giving effect to any change in circumstances applicable under clause (i)(a) and assuming that the Rule as in effect and interpreted at the time of the amendment or supplement was in effect at the time of the primary offering; and (iii) such amendment or supplement does not materially impair the interests of the Owners under the Rule.

valorem taxes are required to be levied upon all property taxable by the Issuer, without limitation as to rate or amount.

This Note shall not be valid or become obligatory for any purpose or be entitled to any security or benefit under the Resolution until the Certificate of Authentication hereon shall have been executed by the manual signature of the Registrar.
