#### Background

On August 28, 2013, the Council approved Business Item 2013-225 authorizing the Regional Administrator to submit grant applications to CTIB for 2014 Funding. On October 16, 2013, the Council approved Business Item 2013-271 stating these grant applications were consistent with the adopted 2030 Transportation Policy Plan. This proposed action will allow agreements to be executed with CTIB to accept the grant awards.

#### Rationale

CTIB operating grant funds will provide 50% of the net cost of transitway operations for calendar year 2014.

The CTIB capital grant for Southwest LRT is for continuing Project Development activities in 2014.

# Funding

The CTIB Funding for the operating grants is included as part of the proposed 2014 operating budget to be adopted by the Council on December 11, 2013. CTIB requires that capital projects maximize the use and availability of federal funds and have a 10% local contribution from the state. CTIB grant funds will provide 30% of overall funding and will be used in conjunction with other local sources of funding available to the SWLRT Project, including funding from the State of Minnesota (10%) and the Hennepin County Regional Railroad Authority (10%).
