Proposed Action

That the Metropolitan Council authorize the Regional Administrator to award and execute a 5-yr. contract to provide Uniform Rental Services for MCES staff with G & K Services, Inc., Contract 12P223A, for a total \$382,610.

Summary of Committee Discussion/Questions

Council member Rummel asked if uniforms are replaced as needed. Staff explained that if a garment is lost or damaged, and is less than a year old, we pay 50% of the cost of a new garment. If the garment is more than a year old, we're not charged for a replacement.

Motion to approve the proposed action was made, seconded, and passed, with Council member Reynoso abstaining.

Proposed Action

That the Metropolitan Council authorize the Regional Administrator to award and execute a 5-yr. contract to provide Uniform Rental Services for MCES staff with G & K Services, Inc., Contract 12P223A, for a total \$382,610.

Background

MCES staff involved in the collection and treatment of wastewater are provided with uniforms to maintain a professional appearance, to satisfy OSHA safety requirements, and to protect the employees from exposure to contaminated and unpleasant materials.

A formal Invitation for Bids (IFB) was issued for uniform rental services, which include the supply and laundering of uniforms and lab coats. Two bids were received on February 8, 2013, ranging from \$382,610 to \$396,867. Both bidders were deemed responsive, and the lowest bidder, G & K Services, Inc., was determined to be a responsible bidder. The low bidder was required to submit samples of the uniforms in the fabric, color and sizes required in the IFB.

Rationale

Uniforms are required because the nature of the work done in Environmental Services exposes some employees to various contaminates. Other employees are exposed to the hazards of flames or electric arcs. Those employees are required to wear "Flame-Resistant" (FR) garments. Professional laundry services will be provided under this contract for all uniforms.

Funding

Capital or Operating Budget: Funding is provided from annual operating budgets of individual departments utilizing this service.

Estimated Cost: \$382,610 for a 5-year period
