Proposed Action

That the Metropolitan Council concur with the Transportation Advisory Board (TAB) action to amend the 2013-2016 Transportation Improvement Program (TIP) to add 12 projects on the attached list using a total of \$17,568,279 in federal Surface Transportation Program (STP) funding in 2013.

Background

The annual local program review to determine the status of project delivery in the region resulted in the identification of \$27,580,221 of regional federal funding programmed in 2013 that would not used this year either due to projects being withdrawn or moving to a later year because of a sunset date extension. Under the previous federal law, SAFETEA-LU, MnDOT would assist the region by using these federal funds on its program in the current fiscal year and providing the TAB with an equal amount of funding in future federal fiscal years. The new federal law, MAP-21, now requires that federal funding be managed within each specific federal program (e.g. STP, CMAQ, etc.) and that program funds be encumbered within the fiscal year for which they are appropriated. Therefore it is not possible to manage the unused regional federal funds as has been done in the past.

The TAB discussed options for managing the unused federal funds at its March 20th meeting and recommended that the unused funds be allocated in the following manner:

- 1. Add federal funds to existing, regionally selected, local federal projects that do not currently have an 80% federal share, and cap the increased federal share at 75% of the project total or at an additional \$2.5M per project; and
- 2. Allocate the remaining federal funds to the seven metro counties based on each county's proportional share of annual state aid allocations.

Adding federal funds to existing projects as required under the first option above resulted in spending \$10,011,942 of the unused 2013 federal funds and can be accomplished through an administrative modification to the TIP. The remaining \$17,568,279 of unused 2013 federal funds will be allocated to the counties. This TIP amendment is needed to add the 12 projects (see attached) identified by each county to use its share of the remaining funds.

Rationale

The Transportation Advisory Board approves formal amendments to the Transportation Improvement Program, and the Metropolitan Council concurs with the action of the TAB. All transportation projects that receive federal funding must be included in the TIP. The projects are consistent with the Transportation Policy Plan and meet fiscal constraint because the federal and local funds are sufficient to fully fund these projects. The Minnesota Interagency Air Quality and Transportation Planning Committee determined that the projects were exempt from air quality conformity analysis.

Funding

The 12 projects being added with this amendment are funded with \$17,568,279 in federal Surface Transportation Program (STP) funding in 2013. Specific amounts for each project are shown on the attached list.
