That the Metropolitan Council:

The grant should be financed with:

  - \$20,632 from Metropolitan Council bonds

However, the Council does not under any circumstances represent or guarantee that reimbursement will be granted, and expenditure of local funds never entitles a park agency to reimbursement.

#### Background

Carver County requests two grants to finance 75% of the acquisition of two properties: a 0.5-acre parcel (First Minnetonka City Bank) for \$51,579; and a 0.35-acre parcel (Wenz/Clark) for \$15,520 for the Southwest Regional Trail. Carver County also requests

reimbursement consideration for its 25% match for both grants, for \$17,193 and \$5,173 respectively, from the County's share of a future regional parks capital improvement.

#### Rationale

In 2001, the Metropolitan Council established a Park Acquisition Opportunity Fund grant program to assist regional park agencies in acquiring land for the Regional Park System, provided that land to be acquired was within Metropolitan Council approved master plan boundaries for that particular park or trail unit. To-date, about \$27.6 million has been granted for the acquisition of 2,122 acres.

#### Funding

The Council will finance the two grants from the Parks and Trails Legacy Fund Acquisition Account, one of two accounts in the Park Acquisition Opportunity Fund, using the following revenue sources:

#### Background

Carver County has submitted two grant requests of \$51,579 and \$15,520 respectively to finance up to 75% of the projected costs to acquire a 0.5 acre parcel (First Minnetonka City Bank) and a 0.35 acre parcel (Wenz/Clark) for right-of-way of the Southwest Regional Trail.

Carver County also requests reimbursement consideration of \$17,193 and \$5,173 respectively from the County's share of a future regional parks capital improvement program financed from the Parks and Trails Legacy Fund, for the local 25% match to these grants. The reimbursement consideration of the 25% match is permitted under the amended rules for Park Acquisition Opportunity Grants approved by the Metropolitan Council on January 9, 2013 (Business Item 2012-260).

See Attachments 1 and 2, Letters from Marty Walsh, Carver County and Attachments 3 and 4 which are aerial maps showing the parcels in context with Southwest Regional Trail.

#### Rationale

In 2001, the Metropolitan Council established a Park Acquisition Opportunity Fund grant program to assist regional park agencies in acquiring land for the Metropolitan Regional Park System. Land that is acquired must be within Metropolitan Council approved master plan boundaries for that particular park or trail unit. To-date, about \$27.6 million has been granted for the acquisition of 2,122 acres. The total related acquisition costs and market value of this land is about \$69 million. (See **Attachment 5** at the end of this memorandum that summarizes all grants awarded sorted by Park Agency and sorted by MPOSC District as of April 2013).

#### Funding

The total actual and estimated costs for the First Minnetonka City Bank parcel based on documentation provided by Carver County staff is \$68,772 as shown in Table 1:

Carver County's request for reimbursement consideration of \$15,520 and \$5,173 respectively from the County's share of a future regional parks capital improvement program through the Parks and Trails Legacy Fund, for the local 25% match to these grants is permitted under the amended rules for Park Acquisition Opportunity Grants approved by the Metropolitan Council on January 9, 2013. The timing of when Carver County is reimbursed for any portion of the \$15,520 and \$5,173 is dependent on when funds are provided in a future Regional Park Capital Improvement Program. The Council does not under any circumstances represent or guarantee that a reimbursement will be granted, and expenditure of local funds never entitles a park agency to reimbursement.

These acquisitions qualify for funding from the Parks and Trails Legacy Fund Acquisition Account because the parcels do not contain high quality natural resources. The Park Acquisition Opportunity Fund grants would be financed as shown in Table 5 and 6.

If these grants are awarded, the unobligated balance in the Parks and Trails Legacy Fund Acquisition Account would be at least \$2,185,856. When combining the balance in the Environment and Natural Resources Trust Fund Acquisition Account to acquire high quality natural lands with no structures on them, the total unobligated balance in both accounts is at least \$4,923,386.

#### Known Support / Opposition

The request is consistent with the rules for Park Acquisition Opportunity Fund grants as adopted on January 9, 2013. There is no known opposition to the request.

Carver County intends to purchase land needed to construct the Southwest Regional Trail Connection in Chaska. This parcel identification number is 300340110 and is identified on the attached aerial image. The County will purchase a portion of this parcel at a value of \$59,422.

The total expense related to the acquisition of this parcel is \$68,772. Carver County is requesting a Land Acquisition Opportunity Grant equal to 75% of the acquisition costs or \$51,579. The County will contribute 25% or \$17,193 of the funds needed for the trail right-of-way.

In addition, Carver County requests that its allocation of the 2014 Parks and Trails Funds be eligible to reimburse the County for the local share of trail right-of-way costs for this project.

Dear Mr. Stefferud:

Carver County intends to purchase land and compensate the property owner for the loss of lease payments for a billboard sign. Compensation for land and lease revenue is needed in order to construct a segment of the Southwest Regional Trail in Chaska. The parcel identification number is 300340800 and is identified on the attached aerial image. The parcel has a total acreage of 6.3 acres in size of which the acquisition of .35 acre is needed for the trail. The County will purchase the entire parcel at a value of \$59,860 including the value for lease payments. The value of the land needed for the trail is \$5,510 plus loss revenue from the billboard lease payments of \$6,100. The remaining area of the parcel will be purchased by our County Public Works Department.

The total acquisition cost for the trail is projected to be \$20,693. Carver County is requesting a Land Acquisition Opportunity Grant equal to 75% of the acquisition costs needed for the trail or \$15,520. The County will contribute 25% or \$5,173 of the funds needed for the trail right-of-way.

In addition, Carver County requests that its allocation of the 2014 Parks and Trails Funds be eligible to reimburse the County for the local share of trail right-of-way costs for this project.




