**Subject:** Request for Reimbursement Consideration for Dakota County Regional Park and Trails Projects

### **Proposed Action**

That the Metropolitan Council consider reimbursing Dakota County up to \$6,303,480 from its share of future Regional Parks Capital Improvement Programs for the following projects:

- 1. Whitetail Woods Regional Park construction \$5,453,480 Site grading, access drive, parking lot, play area, trails, sledding hill, site furnishings, utilities, landscaping, signage, picnic shelter, restroom building, camper cabins and associated phase 1 improvements.
- 2. Mississippi River Regional Trail-trailhead construction \$450,000

  Parking lot, bathroom building, utilities, signs, landscaping, trails, site furnishings and miscellaneous site amenities to serve the regional trail at Swing Bridge Park in Inver Grove Heights.
- 3. Mississippi River Regional Trail -Spring Lake Park engineering \$400,000 Design and engineering for regional trail from Schaars Bluff picnic area to the western park boundary.

However, the Council does not under any circumstances represent or guarantee that reimbursement will be granted, and expenditure of local funds never entitles a park agency to reimbursement.

### **Summary of Committee Discussion/Questions**

Chair Cunningham inquired why the action states that the Council will *consider* reimbursing Dakota County in a future capital improvement program (CIP). Jan Youngquist, Planning Analyst, indicated that typically projects are funded through the regional parks CIP and then the park implementing agency undertakes the work. Sometimes the timing of a project does not correspond to the Council's CIP, however. In these cases, agencies request Council approval of a project prior to commencing the work and that the Council consider reimbursing them for their expenditures in a future regional parks CIP.

The Community Development Committee unanimously approved the proposed action.

#### Rationale

The request for reimbursement consideration is consistent with Finance Strategy 6 from the 2030 Regional Parks Policy Plan.

Metropolitan Council action is required to approve specific grants to Dakota County. The Council does not under any circumstances represent or guarantee that reimbursement will be granted, and expenditure of local funds never entitles a park agency to reimbursement.

# **Known Support / Opposition**

There was not a quorum of the Metropolitan Parks and Open Space Commission (MPOSC) at its June 4 meeting, so MPOSC members could not formally approve a motion. However, there was a unanimous consensus of the MPOSC members in attendance to support the staff recommendation. There is no known opposition to the request.

   Parking lot, bathroom building, utilities, signs, landscaping, trails, site furnishings and miscellaneous site amenities to serve the regional trail at Swing Bridge Park in Inver Grove Heights.
- 3. Mississippi River Regional Trail -Spring Lake Park engineering \$400,000 Design and engineering for regional trail from Schaars Bluff picnic area to the western park boundary.

#### Rationale

Dakota County is requesting that these costs be considered for reimbursement from its share of future regional parks capital improvement programs. The request for reimbursement consideration is consistent with Finance Strategy 6 from the *2030 Regional Parks Policy Plan*, which states:

### Finance Strategy 6: Reimbursement

"...Reimbursement will be considered for development provided the project in question is consistent in timing, scale, type and cost with an approved master plan; that all information required for the development grant is submitted to the Council prior to the regional park implementing agency undertaking the project; and that the Council approves the project..."

This request meets the terms of Finance Strategy 6 for the following reasons:

- 1. The timing, scale and cost for the projects are consistent with the Metropolitan Council approved master plans for Whitetail Woods Regional Park (Project 1) and Mississippi River Regional Trail (Projects 2 and 3). The Whitetail Woods Regional Park master plan was approved in May 2012 (Referral No.50024-1) and the Mississippi River Regional Trail master plan that includes projects 2 and 3 was approved in July 1999 (Referral No. 15553-5).
- 2. Sufficient information has been submitted in this request regarding what would be financed with a Council grant to meet the requirements of Finance Strategy 6. In this case, that information is contained in the County's letter **Attachment 1**.
- 3. Dakota County is requesting Metropolitan Council approval for County expenditures on this project prior to undertaking it.

### **Funding**

Funding for the future reimbursement of the projects may be awarded through Dakota County's share of Regional Parks Capital Improvement Programs (CIP). Metropolitan Council action is required to approve specific grants to Dakota County. The Council does not under any circumstances represent or guarantee that reimbursement will be granted, and expenditure of local funds never entitles a park agency to reimbursement.

#### **Known Support / Opposition**

There is no known opposition to this request as it is consistent with Finance Strategy 6 from the 2030 Regional Parks Policy Plan.
