Proposed Action

That the Metropolitan Council concur with the Transportation Advisory Board (TAB) action to amend the 2013-2016 Transportation Improvement Program (TIP) to add three projects on the attached list using a total of \$170,000 in federal Safe Routes to School funding in 2014.

Background

The federal Safe Routes to School non-infrastructure grants support education, encouragement, enforcement, or evaluation activities related to safe walking and bicycling to school. MnDOT conducts a statewide solicitation for local implementation projects that help more children walk and bicycle safely to school. The state fiscal year (SFY) 2014 Safe Routes to School (SRTS) non-infrastructure grant solicitation awards were recently announced, and three projects were selected in the region. Because the timing of project selection was not compatible with the TIP and STIP development, an amendment is needed to add them to SFY 2014 of the 2013-2016 TIP.

Rationale

The Transportation Advisory Board approves formal amendments to the Transportation Improvement Program, and the Metropolitan Council concurs with the action of the TAB. All transportation projects that receive federal funding must be included in the TIP. The projects are consistent with the Transportation Policy Plan and meet fiscal constraint because the federal and local funds are sufficient to fully fund these projects. The Minnesota Interagency Air Quality and Transportation Planning Committee determined that the projects were exempt from air quality conformity analysis.

Funding

The three projects being added with this amendment are funded with \$170,000 in federal Safe Routes to School funding in 2014. Safe Routes to School projects do not require a local match. Specific amounts for each project are shown on the attached list.
