Subject: Park Acquisition Opportunity Fund Grant for Vermillion Highlands Greenway and Rosemount Greenway Regional Trails (Klein Parcel), Dakota County

Proposed Action

That the Metropolitan Council:

1. Authorize a grant of up to \$270,000 from the Parks and Trails Legacy Fund Acquisition Account to Dakota County to finance up to 75% of the costs to acquire approximately 8.5 acres in a 100-foot wide, 3,200-foot long greenway corridor easement for the Vermillion Highlands Greenway and Rosemount Regional Greenway Regional Trails. The grant should be financed with:
 - \$162,000 from the FY2014 Parks and Trails Legacy Fund appropriation, and
 - \$108,000 from Metropolitan Council bonds
2. Authorize the Community Development Director to sign the grant agreement and accompanying documents.
3. Consider reimbursing Dakota County up to \$90,000 from its share of a future Regional Park Capital Improvement Program for its 25% share of the total acquisition costs. The Council does not under any circumstances represent or guarantee that reimbursement will be granted, and expenditure of local funds never entitles a park agency to reimbursement.

Summary of Committee Discussion/Questions

Proposed Action

That the Metropolitan Council:

1. Authorize a grant of up to \$270,000 from the Parks and Trails Legacy Fund Acquisition Account to Dakota County to finance up to 75% of the costs to acquire approximately 8.5 acres in a 100-foot wide, 3,200-foot long greenway corridor easement for the Vermillion Highlands Greenway and Rosemount Regional Greenway Regional Trails. The grant should be financed with:
 - \$162,000 from the FY2014 Parks and Trails Legacy Fund appropriation, and
 - \$108,000 from Metropolitan Council bonds
2. Authorize the Community Development Director to sign the grant agreement and accompanying documents.
3. Consider reimbursing Dakota County up to \$90,000 from its share of a future Regional Park Capital Improvement Program for its 25% share of the total acquisition costs. The Council does not under any circumstances represent or guarantee that reimbursement will be granted, and expenditure of local funds never entitles a park agency to reimbursement.

Background

In 2001, the Metropolitan Council established a Park Acquisition Opportunity Fund grant program to assist regional park agencies in acquiring land for the Metropolitan Regional Park System. Land that is acquired must be within Metropolitan Council approved master plan boundaries for that particular park or trail unit. To-date, about \$32.6 million has been granted to acquire 2,408 acres.

On August 9, 2013 the Council received Dakota County's acquisition opportunity grant request for \$270,000 to finance up to 75% of the estimated total costs to acquire approximately 8.5 acres in a 100-foot wide, 3,200-foot long greenway corridor easement.

The greenway corridor is part of the Vermillion Highlands Greenway and Rosemount Regional Greenway Regional Trails. The 8.5-acre trail corridor is located in the City of

Rosemount, MN. The County is acquiring a conservation easement for the trail corridor, while the City of Rosemount will own the property in fee title.

The master plans for the Rosemount Greenway regional trail and the Vermillion Highlands Greenway regional trail show this segment of planned trail. The proposed acquisition is consistent with the approved master plans. The Metropolitan Council approved both master plans on November 28, 2012 (MC Items 2012-354 and 2012-355).

All park acquisition opportunity grant agreements include an "agreement and restrictive covenant" that park agencies record to ensure that the property remains in regional recreation use. In this case, Metropolitan Council staff have collaborated with Dakota County and the City of Rosemount staff to incorporate the terms of the restrictive covenant in the permanent regional trail corridor easement. The restrictive covenant terms include an option for the Metropolitan Council to place wastewater conveyance facilities within the permanent regional trail corridor easement area under an additional easement if that is needed in the future. The Metropolitan Parks and Open Space Commission did not act on proposed action number 2 at their September 3 meeting because the terms for the permanent regional trail corridor easement were created after that meeting.

Rationale

The request is consistent with the adopted rules for Park Acquisition Opportunity Fund Grants (MC Item 2012-260).

Funding

The Parks and Trails Legacy Fund balance is \$2,259,152 based on the Metropolitan Council's approval of Ramsey County's grant for the Phalen Keller Regional Park.

Dakota County's total acquisition costs are \$360,000, as shown in Table 1.

The total grant request amount is \$270,000. The Park Acquisition Opportunity Fund grant will be financed with the following revenue sources, shown in Table 2.

If the Metropolitan Council approves this grant and the Ramsey County grant, the Parks and Trails Legacy Fund Acquisition Account balance is \$1,989,152.

Known Support / Opposition

The Metropolitan Parks and Open Space Commission (MPOSC) unanimously supported the recommendations presented in the attached memorandum to the MPOSC at their September 3, 2013 meeting.

There is no known opposition to Dakota County's grant request.

Proposed Action

That the Metropolitan Council:

1. Authorize a grant of up to \$270,000 from the Parks and Trails Legacy Fund Acquisition Account to Dakota County to finance up to 75% of the costs to acquire approximately 8.5 acres in a 100-foot wide, 3,200-foot long greenway corridor easement for the Vermillion Highlands Greenway and Rosemount Regional Greenway Regional Trails. \$162,000 from the FY2014 Parks and Trails Legacy Fund appropriation, and

\$108,000 from Metropolitan Council bonds

2. Consider reimbursing Dakota County up to \$90,000 from its share of a future Regional Park Capital Improvement Program for its 25% share of the total acquisition costs. The Council does not under any circumstances represent or guarantee that reimbursement will be granted, and expenditure of local funds never entitles a park agency to reimbursement.

Background

On August 9, 2013 the Council received Dakota County's acquisition opportunity grant request for \$270,000 to finance up to 75% of the estimated total costs to acquire approximately 8.5 acres in a 100-foot wide, 3,200-foot long greenway corridor easement. (Attachment 2)

The greenway corridor is part of the Vermillion Highlands Greenway and Rosemount Regional Greenway Regional Trails. The County is acquiring a conservation easement for the trail corridor, while the City of Rosemount will own the property in fee title. The regional greenway corridor is part of a wider open space greenway to accommodate the trail and greenway as defined in the greenway master plans for the Vermillion Highlands Greenway and Rosemount Greenway regional trails. The 8.5-acre trail corridor is located in the City of Rosemount, MN.

Dakota County's letter (Attachment 1) describes the trail corridor conservation easement acquisition, transfer of ownership, and corridor location. It outlines the corridor conservation easement appraised value, closing costs, title insurance and

other acquisition costs. The acquisition costs total \$360,000, and Dakota County requests a park acquisition opportunity fund grant for 75% of the total cost, \$270,000.

The master plans for the Rosemount Greenway regional trail and the Vermillion Highlands Greenway regional trail show this segment of planned trail. Attachment 3 shows the proposed acquisition in context with the greenway trail master plans, and show that the proposed acquisition is consistent with the master plans. The Metropolitan Council approved both master plans on November 28, 2012 (2012-354 and 2012-355).

Dakota County's 25% share of the total acquisition costs is \$90,000, and the County requests that the Council consider reimbursement from a future regional parks capital improvement program. The County's request is consistent with the Park Acquisition Opportunity Grant Rules approved by the Metropolitan Council on January 9, 2013 (Business Item 2012-260).

Rationale

In 2001, the Metropolitan Council established a Park Acquisition Opportunity Fund grant program to assist regional park agencies in acquiring land for the Metropolitan Regional Park System. Land that is acquired must be within Metropolitan Council approved master plan boundaries for that particular park or trail unit. To-date, about \$32.6 million has been granted to acquire 2,408 acres.

All park acquisition opportunity grant agreements include an "agreement and restrictive covenant" that park agencies record to ensure that the property remains in regional recreation use. The Metropolitan Council's action authorizes the Community Development Director to sign the grant agreement and accompanying documents including the restrictive covenant.

Funding

The Parks and Trails Legacy Fund balance is \$2,259,152 based on the Metropolitan Council's approval of Ramsey County's grant for the Phalen Keller Regional Park.

Dakota County's total acquisition costs are \$360,000, as shown in Table 1.

If the Metropolitan Council approves this grant and the Ramsey County grant, the Parks and Trails Legacy Fund Acquisition Account balance is \$1,989,152.

Known Support / Opposition

The request is consistent with the rules for Park Acquisition Opportunity Fund Grant Rules (MC Item 2012-260). The Council has received no communication of known opposition to the County's grant request.

Dakota County requests Metropolitan Council consideration authorizing an Acquisition Opportunity Fund ("AOF") grant for the purchase of a regional greenway corridor easement that is included in both the Vermillion Highlands and Rosemount Regional Greenway Master Plans. See enclosed Attachment A: Site Map.

The regional greenway corridor easement consists of a 100-foot-wide, 3,200-foot-long corridor, encompassing approximately 8.5 acres. The cost for the greenway corridor easement is \$350,000. Appraisal, closing, and title insurance costs are estimated to be \$10,000 for a total project cost of \$360,000.

Dakota County requests an AOF grant in the amount of \$270,000, which is 75 percent of the total estimated expenses for this acquisition. Dakota County will match the AOF grant with \$90,000 of its funds. In addition, Dakota County requests that the Metropolitan Council consider reimbursing the County up to \$90,000 for these matching funds from part of the County's share of future regional park capital improvement programs.

Acquisition of this regional greenway corridor easement is part of a broader effort to provide recreational opportunities and protect natural resources and it is useful for the Metropolitan Council to be aware of this context. The regional greenway corridor easement is part of a 143-acre parcel that was acquired by a local bank, Klein Bank,

through the foreclosure process when a development plan failed. Since that time, Dakota County has been in discussions with Klein Bank, the City of Rosemount, and others to explore alternative scenarios that would protect the natural resource values of the larger parcel and provide recreational amenities for the public.

As a result of these discussions, Dakota County will accomplish the following:

1. Acquire the 8.5-acre, 3,200-foot-long regional greenway corridor easement that is subject of this AOF grant request;
2. Acquire an additional easement surrounding the regional greenway corridor easement to protect approximately 29.8 additional acres of open space; and
3. Acquire a continuous 3,200-foot-long shoreland easement around and including most of a 17-acre lake, preventing development within the shoreland easement and providing public access via a non-paved trail along the lake.

Dakota County will pay an additional sum (that is not part of this AOF grant request) to acquire the shoreland easement. Klein Bank will donate the value of the easement on the 29.8 acres of open space surrounding the regional greenway corridor.

The land that will be encumbered by these easements will be owned by the City of Rosemount. Klein Bank will convey title to this land to a wholly-owned subsidiary, RIOU Property 2 LLC, which, in turn, will convey title to the City of Rosemount. A new developer will build residential homes on the balance of the property, respecting the natural resource values and integrating the Rosemount and Vermillion Highland Regional Greenways into the development design.

This AOF grant is based on the following estimated expenses:

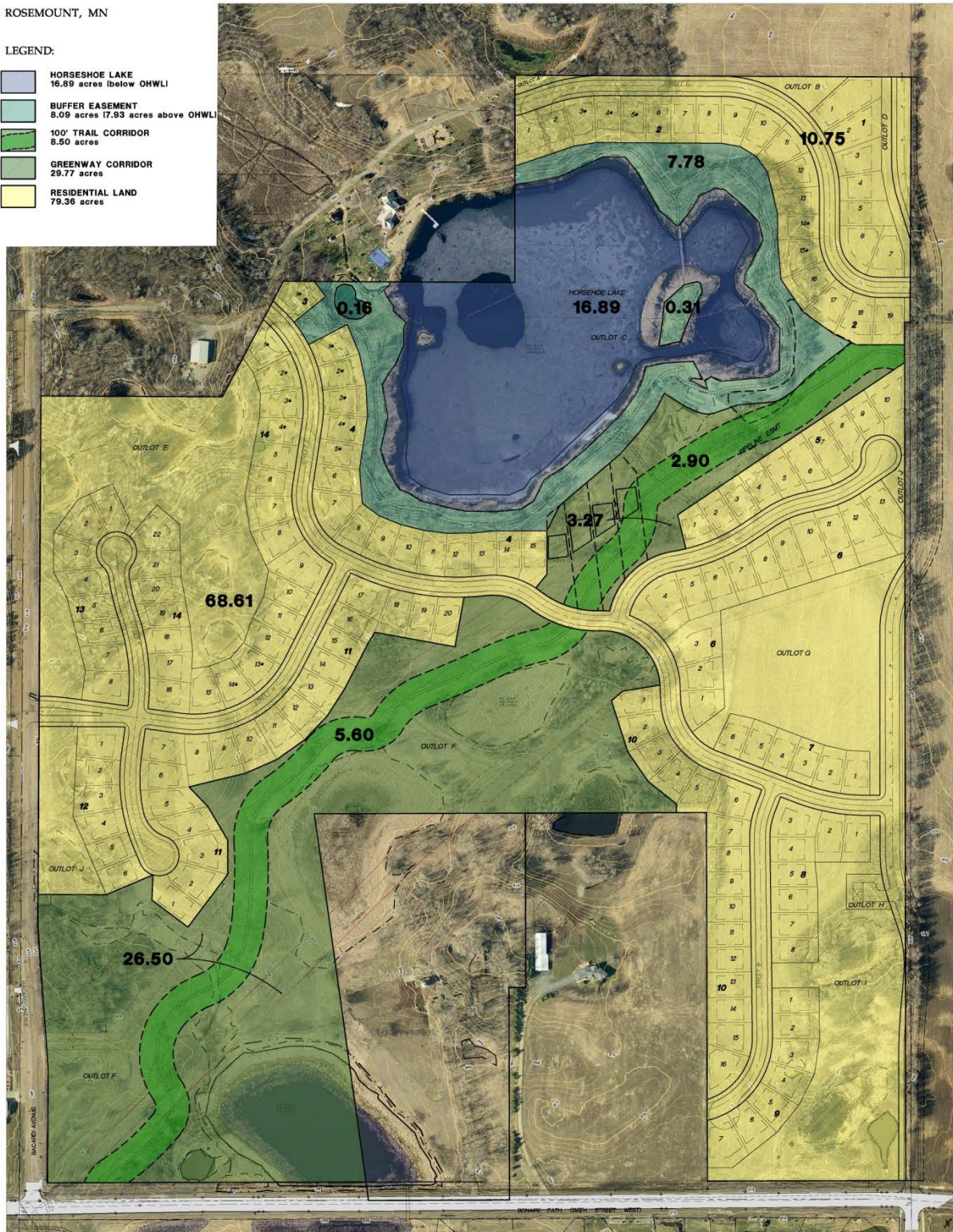

ROSEMOUNT, MN

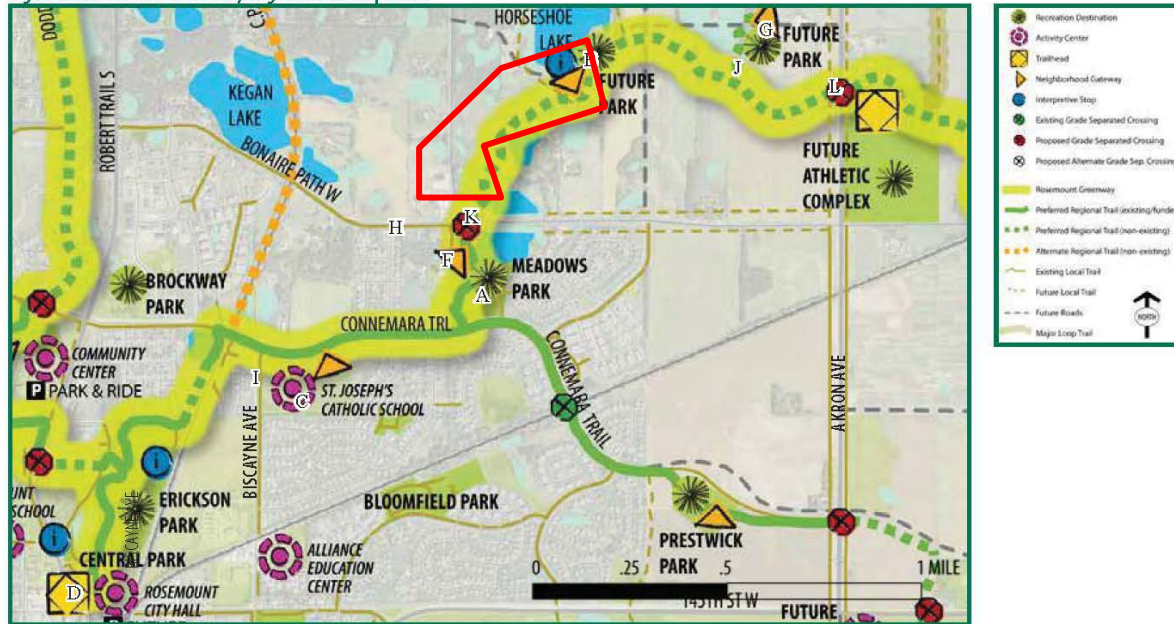
