## Subject: Automatic Passenger Counter equipment for Light Rail Vehicles

## **Proposed Action**

That the Metropolitan Council authorize a change order with Siemens in an amount of \$695,581 to the Low Floor Light Rail Vehicle (LRV) contract to provide for the procurement of automatic passenger counter equipment (APC) on an additional 30 LRV's.

# Summary of Committee Discussion/Questions

Metro Transit Assistant Director Rail Maintenance Rick Carey presented this item and answered a question about whether all LRVs ordered in the future will have APCs. Lamb added that this is primarily for the Green Line because it is so integrated with the bus connections and is also important for FTA reporting.

Council Member Elkins moved the item, seconded by Council Member Munt. The item passed unanimously, and was subsequently placed on the consent agenda of the full Council.

### **Proposed Action**

That the Metropolitan Council authorize the Regional Administrator:

- To execute a professional services contract with Kimley-Horn and Associates, Inc. for design and engineering on the A Line (Snelling Avenue) bus rapid transit (BRT) line and arterial BRT prototype station in the amount of \$1,948,255.
- To issue a Notice-to-Proceed to Kimley-Horn and Associates, Inc. in an amount not to exceed \$1,134,255 for design services related to Phase I of the project.

### Background

Metro Transit requires a design consultant to provide design services for A Line BRT systems and station integration and the prototype arterial BRT station to be deployed region-wide as the system is built out.

A request for proposals (RFP) was issued on August 27, 2013 seeking proposals for design services. Five firms responded to the RFP. An evaluation panel representing Council staff and project partners evaluated the proposals and ranked them in accordance with established Council procedures for federally funded projects, recommending award to Kimley-Horn and Associates, Inc.

Contract 13P216 will be structured in two phases, authorized by work order, in order to advance design using available funding. A Phase I work order, with a not-to-exceed amount of \$1,134,255, will be authorized concurrent with contract authorization. A future Phase II work order, with a not-to-exceed amount of \$814,000 or up to the remaining total contract value less Phase I, will be authorized when additional funding becomes available in mid-2014.

### Rationale

Professional services contracts in excess of \$500,000 require Council approval.

# Funding

Funding for Phase I of this contract is available within projects 61217 and 63114.

# Known Support / Opposition

Project partners participated in the evaluation and ranked the Kimley-Horn proposal as the most advantageous for the Council. There is no known opposition.
