## **Proposed Action**

That the Metropolitan Council approve the attached public comment process and proposed Metro Mobility Downtown Zone fare adjustment for the purpose of public comment prior to Council adoption of a fare adjustment.

## Background

- Under the American's with Disabilities Act (ADA) the fare for paratransit services cannot exceed more than two times the local fixed route fare for a comparable trip.
- In both the cities of Minneapolis and Saint Paul there is a "Downtown Zone" for fixed routed. Fares for trips which begin and end within the Downtown Zone are \$0.50 on all fixed routes.
- The fare for all Metro Mobility trips which are wholly within either Downtown Zone should not exceed \$1.00.
- Metro Mobility trips which are wholly within either Downtown Zone are currently paying either the \$4.00 peak or \$3.00 off peak Metro Mobility fare.

# Rationale

Although Council Policy does not require public hearings to reduce a fare, staff recommends a public comment process, including two public meetings, to allow for presentation of the proposed fare change to \$1.00 for peak and off peak Metro Mobility trips wholly within either of the Downtown Fare Zones.

While a fare lower than \$1.00 is allowable, staff recommends the \$1.00 maximum fare as permitted by the ADA given the 2013 Metro Mobility subsidy per ride of around \$23.

# Funding

Using current ridership information, staff estimates that 2,190 trips (1,038 trips in Minneapolis and 1,152 in Saint Paul) per year are wholly within the Downtown Zones. With a \$1.00 fare this translates into approximately \$6,850 less in annual fare revenue. The 2014 Metro Mobility operating budget is \$59,694,929.


