## **Background**

On August 27, 2014, the Council approved Business Item 2014-194 authorizing the Regional Administrator to submit grant applications to CTIB for 2015 funding. On October 22, 2014, the Council approved Business Item 2014-248 stating these grant applications were consistent with the adopted 2030 Transportation Policy Plan. All submitted grants, with the exception of the I-35W Express Bus capital grant request, were approved by CTIB. This proposed action will allow agreements to be executed with CTIB to accept the grant awards.



All CTIB capital and operating grants are subject to standard conditions including narrative and financial reports. Additional special conditions of note include the following:

## Capital:

• By September 1, 2015 the Council shall identify allocation of a 10% local share (\$15,000,000) for the Orange Line.

#### Operating:

• The final operating budgets for Red Line and Cedar Express will be submitted to CTIB once MVTA's Cost Allocation Plan is deemed federally compliant by Council staff.

#### **Rationale**

CTIB operating grant funds will provide up to 50% of the net cost of transitway operations for calendar year 2015. CTIB capital grant funds will provide a funding share ranging from 30% to 80%, with Cedar Grove Transit Station receiving the highest share of 80%. Capital grants will fund vehicle purchases, transit station construction and project development work.

## **Funding**

The CTIB funding is included as part of the proposed 2015 operating and capital budgets to be adopted by the Council on December 10, 2014.
