#### **Proposed Action**

That the Metropolitan Council adopt a resolution, required by Minnesota Housing, to authorize the Regional Administrator to execute an agreement to increase the program size and funding for the Bridges Rental Assistance Program.

#### Background

The Council's Housing and Redevelopment Authority (Metro HRA), in partnership with Anoka, Hennepin and Ramsey Counties, has administered the Bridges Program since 1993. The Bridges Program provides a tenant-based housing subsidy for persons with mental illness. Recipients choose rental housing from the private market wherein the Metro HRA provides the rent subsidy. The county mental health divisions provide support services designed to enable recipients to successfully maintain an independent living environment.

The amended grant award will provide funding to assist approximately 17 additional households for a period of fifteen months. The previous grant award for this program was \$2,650,000, which assists approximately 185 households through a two-year grant term. The additional award will increase overall program size to approximately 202 households.

#### Rationale

The Metropolitan Council adopted a resolution on June 12, 2013 for continued Bridges Rental Assistance Program funding and authorizing the Regional Administrator to execute continuation grant agreements for the program.

#### **Funding**

The funding award for the period April 1, 2014 through June 30, 2015, for this incremental increase, is \$158,000.

## RESOLUTION AUTHORIZING THE REGIONAL ADMINISTRATOR TO EXECUTE AN AMENDMENT TO THE GRANT AGREEMENT WITH MINNESOTA HOUSING FOR THE BRIDGES RENTAL ASSISTANCE PROGRAM
