#### **Background**

Metro Transit has developed a draft Project Plan Update to document the locally-preferred components of the METRO Orange Line BRT project based on 2013 station planning and design, detailed service planning, and refined cost estimates. The Project Plan Update, upon completion, will serve to inform an application to the Federal Small Starts program, help FTA determine an environmental path for the Orange Line, and update the Council's Transportation Policy Plan.

This comment period encourages transparent and meaningful discussion with the public about the progression of the Orange Line project, and provides an opportunity for Metro Transit and Metropolitan Council to better understand the preferences and needs for BRT in various communities in the I-35W corridor. This work supplements engagement activities outlined and implemented as part of the 2013 *Orange Line Public Engagement Plan*.

#### Rationale

A formal public comment period or public hearing is not required at this stage of planning, however, the Project Plan Update is intended to provide critical direction and focus as the Orange Line enters Small Starts Project Development and begins environmental processes this year.

### **Funding**

The Project Plan Update is funded using Metro Transit operating budget resources, supplemented by capital project funding partnerships at specific station locations.
