Proposed Action

That the Metropolitan Council concur with the Transportation Advisory Board (TAB) action to award Congestion Mitigation Air Quality (CMAQ) funds to seven transportation demand management (TDM) projects at the recommended funding level per the attachment.

Background

The Metropolitan Council released the CMAQ TDM solicitation at its September 25, 2013 meeting for \$1.2 million in available funds. The application deadline was November 6, 2013, with 13 submitted applications requesting \$2,091,679 in funding.

Evaluation criteria included: (1) project clarity and readiness; (2) integration and coordination; (3) innovation; (4) impact on congestion; and (5) impact on air quality. A scoring committee was established with representatives from: Metro Transit Service Development; MnDOT Metro District; Metropolitan Transportation Services; Best Buy; and an independent consultant with a background in TDM.

Six projects are recommended to be fully-funded and one partially funded.

After the scoring process was completed, Tele-Commuter Resources submitted an appeal. The appeal was addressed in the manner described in the solicitation packet. The score improved slightly, but did not result in a change in the rankings.

Rationale

The TAB is responsible for soliciting and evaluating projects to receive the federal transportation funding allocated to the region. The Council reviews the TAB actions for consistency with regional goals and plans and concurs with actions it finds to be consistent.

Funding

The \$1.2 million in available funding is the result of previous conversations with the TAB and results of the 2010 TDM Evaluation and Implementation Study. \$600,000 is anticipated to be available annually and the intent is to offer a solicitation every other year for \$1.2 million.

Known Support / Opposition

Action supported by TAB. No known opposition.
