Proposed Action

That the Metropolitan Council:

- Authorize a grant of up to \$25,071 from the Parks and Trails Legacy Fund Acquisition Account
 to Three Rivers Park District to finance up to 75% of the costs to acquire two permanent public
 trailway easements for the Intercity Regional Trail described in Attachment 2. The grant will be
 financed as follows:
 - \$15,043 from the FY2014 Parks and Trails Legacy Fund appropriation, and
 - \$10,028 from Metropolitan Council bonds

Three Rivers Park District will match the grant with up to \$8,357, its 25% share of the total acquisition cost.

2. Authorize the Community Development Director to sign the grant agreement and accompanying documents including the restrictive covenant.

Proposed Action

That the Metropolitan Council:

- 3. Authorize a grant of up to \$25,071 from the Parks and Trails Legacy Fund Acquisition Account to Three Rivers Park District to finance up to 75% of the costs to acquire two permanent public trailway easements for the Intercity Regional Trail described in Attachment 2. The grant will be financed as follows:
 - \$15,043 from the FY2014 Parks and Trails Legacy Fund appropriation, and
 - \$10,028 from Metropolitan Council bonds

Three Rivers Park District will match the grant with up to \$8,357, its 25% share of the total acquisition cost.

4. Authorize the Community Development Director to sign the grant agreement and accompanying documents including the restrictive covenant.

Background

Three Rivers Park District requests a second park acquisition opportunity fund grant of up to \$25,071 to acquire two permanent public trailway easements for the Intercity Regional Trail in the City of Bloomington (Attachment 1). These two easements represent the Park District's third grant request to acquire the regional trail, and total 13 of the anticipated 17 trailway easements needed to acquire the trail over the next several months. The Park District previously requested grants of \$55,400 and \$71,276 for 11 easements for the regional trail in the Cities of Bloomington and Richfield.

The two easements are .02 acres in size, or 987 square feet and include the CSM Freeway property at 7850 12th Avenue South (Attachment 5), and the Matias property at 8412 Old Cedar Avenue South (Attachment 6). The Park District's request summarizes the easements including ownership, size, location and estimated acquisition costs in Attachment 2.

Rationale

The Park District's grant request is consistent with the Park Acquisition Opportunity Fund Rules for the acquisition grant program that assists regional park agencies in acquiring land for the Metropolitan Regional Park System, within approved master plan boundaries.

Assuming the Metropolitan Council approves a \$71,276 grant for acquiring 6

easements for this trail on May 14, the cumulative total of all Park Acquisition Opportunity Fund grants is \$35,092,044 which acquired 2,817.7 acres.

Funding

The Park Acquisition Opportunity Fund has two accounts: the Environment and Natural Resources Trust Fund and the Parks and Trails Legacy Fund. Assuming the Metropolitan Council approves a \$71,276 grant for acquiring six easements for the Intercity Regional trail on May 14, the Parks and Trails Legacy account has a balance of \$2,430,068 which includes \$389,759 from the fiscal year 2014 Parks and Trails Legacy Fund appropriation, and \$2,040,309 of Metropolitan Council bonds.

The Park District's estimated acquisition costs are \$33,428 which includes the purchase price, appraisal, title insurance, taxes and closing costs as shown in Table 1.

The Park Acquisition Opportunity Fund grant will be financed with the revenue sources shown in Table 2. The Park District will fund the required 25% match and does not request future reimbursement from a regional parks capital improvement program.

The Metropolitan Council's approval of this grant to Three Rivers Park District will reduce the Parks and Trails Legacy Fund account balance to \$2,404,997.

Known Support / Opposition

The Metropolitan Parks and Open Space Commission unanimously recommended approval of the proposed action at its meeting on May 6, 2014. The Three Rivers Park District Board authorized purchase of the trail easements on March 6, 2014. There is no known opposition to the Park District's acquisition of the easements for the Intercity Regional Trail, or to the Park District's grant request.

Background

On April 11, 2014, Three Rivers Park District requested a third park acquisition opportunity fund grant of up to \$25,071 to acquire two permanent public trailway easements for the Intercity Regional Trail in the City of Bloomington (Attachment 1). These two easements represent the Park District's third grant request to acquire the regional trail, and total 13 of the anticipated 17 trailway easements needed to acquire the trail over the next several months. The Park District previously requested grants of \$55,400 and \$71,276 for 11 easements for the regional trail in the Cities of Bloomington and Richfield.

The two easements are located along 12th Avenue South and Old Cedar Avenue South, and are .02 acres in size, or 987 square feet. The Park District's request summarizes the easements including ownership, size, location and estimated acquisition costs in Attachment 2.

The Park District's acquisition of these easements is consistent with the Intercity Regional Trail master plan, which the Metropolitan Council approved on October



31, 2012. The master plan indicates that trail easements may be required to develop the regional trail, and shows the location of future easements connected along the regional trail (Attachment 3). The master plan indicates that the 5 mile regional trail extends through Minneapolis, Richfield and Bloomington, will be jointly managed by the Minneapolis Park and Recreation Board, the City of Bloomington and the Park District.

The regional trail is planned to connect Nokomis-Hiawatha Regional Park to the 86th Street Bikeway in Bloomington, and connect to the Nine Mile Creek Regional Trail (Attachment 4). The Park District has set the purchase closing for the easements contingent upon the Metropolitan Council's action on the Park District's grant request.

The easements include the CSM Freeway property at 7850 12th Avenue South (Attachment 5), and the Matias property at 8412 Old Cedar Avenue South (Attachment 6).

Rationale

In 2001, the Metropolitan Council established a Park Acquisition Opportunity Fund grant program to assist regional park agencies in acquiring land for the Metropolitan Regional Park System. Land that is acquired must be within Metropolitan Council approved master plan boundaries for that particular park or trail unit. Assuming the Metropolitan Council approves a \$71,276 grant for acquiring 6 easements for this trail on May 14, the cumulative total of all Park Acquisition Opportunity Fund grants is \$35,092,044 which acquired 2,817.7 acres.

All park acquisition opportunity grant agreements include an "agreement and restrictive covenant" that park agencies record to ensure that the property remains in regional recreation use. The Metropolitan Council's action authorizes the Community Development Director to sign the grant agreement and accompanying documents including the restrictive covenant.

The Park District's grant request is consistent with the Park Acquisition Opportunity Fund Rules.

Funding

The Park Acquisition Opportunity Fund has two accounts: the Environment and Natural Resources Trust Fund and the Parks and Trails Legacy Fund. Assuming the Metropolitan Council approves a \$71,276 grant for acquiring 6 easements for the Inter-City Regional trail on May 14, the Parks and Trails Legacy account has a balance of \$2,430,068 which includes \$389,759 from the fiscal year 2014 Parks and Trails Legacy Fund appropriation, and \$2,040,309 of Metropolitan Council bonds.

The Park District's estimated acquisition costs are \$33,428 which includes the purchase price, appraisal, title insurance, taxes and closing costs as shown in Table 1.

The Metropolitan Council's approval of this grant to Three Rivers Park District leaves an unobligated balance of \$2,404,997 in the Parks and Trails Legacy Fund acquisition account.
