The CCLRT Project needs office space through February 2015 to complete project close-out activities. The current CCLRT lease expires on August 31, 2014. Council action is required to authorize amendments to the lease to extend the terms through the project close-out period.

Rationale

CCLRT staff analyzed several short-term space options and found that extending its current lease for less square footage was more cost-effective than temporarily moving to a Metro Transit facility due primarily to one-time costs of moving and its negative impact on productivity.
