2015 Legislative Session

- \$1.8+ billion surplus
- Over \$1 billion left unspent in 2016-2017 (to date)
- House, Senate and Governor have different priorities
 - Agreed on need for transportation bill; disagreed on funding mechanism
 - E-12 Education Funding
 - Tax bill





2015 Legislative Session

- Governor will call a Special Session to handle remaining business
- Special Session is expected to include at least two bills of interest to the Council
 - Legacy—passed by the House; Senate ran out of time to pass
 - Environment Finance—vetoed by the governor
- Budget bills must be enacted by June 30 to avoid any agency shut downs



Transportation Finance

- **\$76.6 million** per year in 2016-2017 for transit operations
- \$29.7 million re-appropriated from the remaining 2013 SWLRT appropriation of \$37 million
 - \$2 million to Suburban Transit Providers for suburb-to-suburb demonstration project
 - \$200,000 to Transportation Management Organizations
 - Remaining funds go to transit operations, including light rail operations, A-Line operations, and Metro Mobility
- **\$89.82 million** per year base for 2016-2017



Transportation Policy

New member added to the Transportation Advisory **Board (TAB)**

- Added 34th member
- Appointed by the Suburban Transit Association
- Must be elected official from a city receiving Suburban Transit Provider service
- Membership change effective the day after enactment





Legislative-Citizen Commission on Minnesota Resources Bill (LCCMR)

- \$1 million for Park Acquisition Opportunity Fund Grants
 - Funds go to land acquisition
 - From Environment and Natural Resources Trust Fund



Legacy Bill – Did Not Pass

Regional Parks—Parks & Trails Fund

- \$35.403 million for regional park system in FY16-17
- Water Supply—Clean Water Fund
- \$975,000/year to address emerging drinking water supply threats
- \$250,000/year to create a program for municipalities to reduce demand for water







Legacy Policy – Did Not Pass

Clean Water Council Membership

Changes the Metropolitan Council and U of M to nonvoting members





Environment Finance – Vetoed

Metropolitan Regional Park System

\$8.54 million per year for operations and maintenance

- \$2.87 million from general fund
- \$5.67 million from "Lottery in Lieu" fund
- Park Interest Earnings—ends the current dedication of interest to North Mississippi Regional Park
 - Effective January 1, 2018
 - Interest earnings will be shared among all implementing agencies





Environment Finance – Vetoed

MCES Water Supply

\$200,000 per year in FY16-17 for technical and administrative support to Metropolitan Area Water Supply Advisory Committee (MAWSAC)

Policy Changes

- Eliminates requirement that local water supply plans be consistent with the Master Water Supply Plan
- Creates separate Metropolitan Area Water Supply Technical Advisory Committee to advise MAWSAC
- Adds St. Paul Regional Water Services and Minneapolis Water Department to the Policy Advisory Committee
- Requires reports to the legislature starting in 2017 and every 5 years after





Confirmations

Chair and Council Members confirmed by the Senate



What did not happen

- Housing plans and affordable housing allocations require approval by the legislature
- Metropolitan Council governance reform
 - Staggered terms
 - Only local elected officials eligible
 - Local government approval of Members
 - Chair elected by Council
 - "Blue Ribbon Commission" to study structure
