Proposed Action

That the Metropolitan Council ratifies the attached Justification for and Declaration of Emergency for Repairs to the Middle Beltline Interceptor 85-66-370 in St. Paul in the final amount of \$7,473,503.

Background

On May 9, 2014, MCES staff was notified by the City of St. Paul that a sinkhole had developed at the intersection of Johnson Parkway and Phalen Boulevard. Staff responded and found a sinkhole approximately 25 feet in diameter and 25 feet deep in the boulevard adjacent to the roadway. The Middle Beltline Interceptor 85-66-370 passes through this intersection. Wastewater was evident in the bottom of the hole. The downstream meter verified that although the pipe had failed, flow was still being conveyed downstream. Staff immediately contacted Lametti & Sons to begin repair operations. Lametti staff and their subcontractor, Northern Dewatering, were on site within 90 minutes to begin planning the temporary conveyance and repairs. Lametti and Northern Dewatering installed the temporary conveyance piping and pumping and were operational by 5:45 p.m. May 9, 2014 and the situation was stabilized.

Ninety lineal feet of 54-inch diameter reinforced concrete pipe was replaced. Soil that intruded into the pipe was removed. Once cleaned, the pipe was inspected via closed circuit television. The inspection revealed that severe hydrogen sulfide corrosion damage extended north in Interceptor 7122 to Maryland Avenue and south in interceptor 85-66-370 to Case Avenue. A short section of interceptor 1-SO-217 was also in poor condition. The scope of the emergency was expanded to include lining and maintenance structure improvements for interceptor between Maryland Avenue and Case Avenue. Approximately 3,690 feet of 72-inch, 54-inch, and 21-inch diameter reinforced concrete pipe was lined. Two new maintenance access structures were constructed to facilitate the lining work. Six maintenance access structures were rehabilitated or replaced. Significant temporary conveyance systems were required to implement the lining work. Restoration of the area has recently been completed.

On May 13, 2014, the Metropolitan Council Environment Committee ratified the initial *Justification for* and *Declaration of Emergency*, business item number 2014-118, in the amount of \$1,000,000. Following the meeting, it became evident repairs would be substantially greater than the originally estimated cost and had risen from \$1,000,000 to \$5,000,000 or greater. Total final cost to complete the emergency work is \$7,473,502.56.

Rationale

Metropolitan Council has delegated authority to the Regional Administrator to declare emergencies on behalf of the Council when the health, safety or welfare of the public is compromised or potentially compromised, and immediate action is required to address the emergency. The emergency declaration is then presented to the appropriate implementation committee for approval, and placed on a following Council consent list for formal ratification.

Proposed Action

That the Metropolitan Council ratifies the attached *Justification for and Declaration of Emergency* for repair of Middle Beltline Interceptor 85-66-370.

Summary of Committee Discussion/Questions

Discussion occurred regarding how often pipes are inspected which is on a 10 year rotation schedule. This pipe was scheduled to be inspected prior to the collapse. Pipes of this age are not expected to fail this soon. Frequency of inspection is being evaluated due to recent pipe degradation. Other discussion involved whether complete replacement of the line is required. Staff indicated this particular pipe section will be replaced with additional work yet to be determined based on inspection of the pipe.

Motion to approve the proposed action was made, seconded, and passed unanimously.

Following the meeting, it became evident repairs will be substantially greater than originally estimated and the cost estimate has risen from \$1,000,000 to ± \$5,000,000. When final costs are determined, a final ratification will be presented for Council action.
