- 3. Authorize staff to submit a request to the legislature for \$11 million in state bonds for 2016.

Summary of Committee Discussion/Questions

The public hearing was set by Council action on June 24, 2015 and held at the August 17, 2015 Community Development Committee meeting.

At the September 8, 2015 Metropolitan Parks and Open Space Commission (MPOSC) meeting, a commissioner inquired why the percentages for state and council bond dollars differed among the project requests. Staff responded that it was due to the conditions and uses placed on state bond dollars.

The MPOSC voted unanimously to recommend approval.

When the draft regional parks capital improvement program was released for public comment on June 24th, sufficiently detailed information had yet to be received from three implementing agencies (Dakota County, Minneapolis Park & Recreation Board and Three Rivers Park District). Therefore the Council directed those agencies to submit their detailed prioritized project descriptions by the date of the public hearing. The written public comment period was extended to September 1, 2015 to allow additional time for comments to be submitted. At the August 17 public hearing no speakers addressed specific projects in the capital improvement program, but two speakers expressed concern that the detailed information from the three aforementioned implementing agencies had not previously been made available. Council Member Wendy Wulff responded that the information would be posted shortly (on August 18), and would be available for public comment during the extended period. In addition, one emailed comment was sent to MPOSC members on September 8, 2015, also citing concern that not all information was available by the date of the public hearing on August 17th.

- 2. Adopt the 2016-2021 Regional Parks Capital Improvement Program; and
- 3. Authorize staff to submit a request to the legislature for \$11 million in state bonds for 2016.

Background

MN Statutes Section 473.147, Subd. 1 requires the Metropolitan Council, after consultation with the Metropolitan Parks and Open Space Commission, municipalities, park districts and counties in the metropolitan area to prepare and adopt a system policy plan for regional recreation open space as part of the Council's development guide. The law also requires the Council to include a multi-year CIP in the parks policy plan, which should be revised periodically, and to establish criteria and priorities for the allocation of funds from the CIP.

The CIP was considered through a public hearing process as part of the 2040 Regional Parks Policy Plan. The draft CIP was released for public comment on June 24, 2015. The draft was updated on August 18, 2015 with specific project descriptions in priority order from Dakota County, Minneapolis Park & Recreation Board, and Three Rivers Park District. A public hearing was held at the August 17, 2015 meeting of the Community Development Committee. No comments relevant to the CIP were received through the public hearing or written comment process, which was held open through 5:00 PM on September 1, 2015.

The 2016-2021 Regional Parks Capital Improvement Program proposes:

- 1. Spending \$18.33 million every two years for capital improvement projects that are consistent with the Metropolitan Council-approved regional park and trail master plans.
- 2. Funding the CIP with \$11 million in State bonds and \$7.33 million in Council bonds every two years (2016-17, 2018-19 and 2020-21).
- 3. Allocation of the \$18.33 million among the ten regional park implementing agencies is based on a formula in the *2040 Regional Parks Policy Plan*:
 - 70% of the money (\$12,833,000) is allocated based on each park agency's percent of the region's population.



• 30% of the money (\$5,500,000) is allocated based on each park agency's percent of all non-local visits to the regional parks system.

The 2016-2017 portion of the 2016-2021 Regional Parks CIP is the basis for requesting \$11 million of State bonds for consideration by the Legislature in 2016. The final request for the bonds must be submitted by October 16, 2015.

The 2016-2021 Regional Parks CIP is a part of the Metropolitan Council's Unified 2016-2021 CIP along with CIPs for Environmental Services and Transit. The Unified 2016-2021 CIP and the 2016 Unified Capital Budget is prepared in the late summer of 2015 and adopted in early December 2015.

Rationale

Preparation and funding of the *2016-21 Regional Parks CIP* is authorized by State laws (MN Statutes 473.147 and 473.325). The 2016-17 portion of the *Regional Parks CIP* is the basis for requesting State bonds to finance 60% of the CIP. The State bonds are matched with Metropolitan Council bonds to finance 40% of the CIP.

Funding

The funding proposed for the 2016-20 21 Regional Parks CIP is \$11 million of State bonds matched with \$7.33 million of Metropolitan Council bonds for each 2 year period of the CIP. Grants are awarded for projects in the 2016-17 Parks CIP when the funds are appropriated for those projects.

Known Support / Opposition

There is no known opposition.

Executive Summary

MN Statutes Section 473.147, Subdivision 1 requires the Metropolitan Council, after consultation with the Metropolitan Parks and Open Space Commission (MPOSC), municipalities, park districts and counties in the metropolitan area to prepare and adopt a system policy plan for regional recreation open space as part of the Council's development guide. The law also requires the Council to include a multi-year capital improvement program (CIP) in the parks policy plan, which should be revised periodically, and to establish criteria and priorities for the allocation of funds from the capital improvement program. The CIP must be considered through a public hearing process as part of the 2040 Regional Parks Policy Plan.

The draft 2016-2021 Regional Parks Capital Improvement Program proposes:

- 1. Spending \$18.33 million every 2 years for capital improvement projects that are consistent with the Metropolitan Council-approved regional park and trail master plans where the projects are located.
- 2. Funding the CIP with \$11 million of State bonds and \$7.33 million of Metropolitan Council park bonds every 2 years (2016-17, 2018-19 and 2020-21).

This report contains the Council's list of projects proposed to be financed with \$11 million of State bonds and \$7.33 million of Metropolitan Council park bonds every 2 years (2016-17, 2018-19 and 2020-21).

The 2016-2017 portion of the 2016-2021 Regional Parks CIP is the basis for requesting \$11 million of State bonds for consideration by the Legislature in 2016.

Preparation and funding of the 2016-21 Regional Parks CIP is authorized by State laws (MN Statute 473.147 and MN Statute 473.325). The 2016-17 portion of the Parks CIP is the basis for requesting State bonds to finance 60% of the CIP. The State bonds are matched with Metropolitan Council bonds to finance 40% of the CIP.

Grants are awarded for projects in the 2016-17 Parks CIP when the funds are appropriated for those projects.

Regional Parks System Management Structure

The organizational structure of the Regional Parks System is unique. It is built upon a strong partnership among the Council and several governmental agencies, including cities, counties, and special park districts. While each agency has a role in the Regional Parks System, collaboration is the cornerstone and the strength of the Regional Parks System.

Metropolitan Council Role

Regional Parks System legislation directs the Council to take the leading role in providing for a Regional Parks System that will complement the recreational open space opportunities provided in the area by the federal, state and local units of government. State law gives the Council the authority to determine which parks and trails in the seven-county area are included in the Regional Parks System and to generally identify areas that should be acquired for the Regional Parks System. The Council is charged with determining whether these lands are regionally important and would collectively provide a balanced system of outdoor recreation for the region.

The Council also contributes and administers funding to the regional park implementing agencies to acquire, develop and operate the Regional Parks System.

Regional Park Implementing Agencies Role

Cities, counties, and special park districts own and operate regional parks and trails. The agency partners that own and operate the Regional Parks System are called regional park implementing agencies. A map of the regional park implementing agency areas is shown in Figure 1-1.



Allocation of CIP funds among 10 regional park implementing agencies

Allocating the \$18.33 million among the ten regional park implementing agencies is based on a formula in the *2040 Regional Parks Policy Plan*.

- 70% of the money (\$12,833,000) is allocated based on each park agency's percent of the region's population.
- 30% of the money (\$5,500,000) is allocated based on each park agency's percent of all nonlocal visits to the regional parks system

The following tables depict how the allocation to each park agency is calculated. Table 1 depicts the percent of the 2013 population and non-local visits for each Park Agency, which is the most current data available.

The 30% of \$18.33 million is allocated based on the park agency's percent of all non-local visits. The combined allocation from both factors in the formula is highlighted in yellow.

Park Agencies submitted to the Metropolitan Council proposed projects to be funded from their allocation for each 2-year period of the CIP. The proposed projects must be consistent with Metropolitan Council-approved master plans for the park or trail where the project is located.

Projects are listed in priority order. If less funds are appropriated to fund the CIP, each park agency allocation would be cut proportional to its share of the CIP. For example Anoka County's share of the CIP is 10.02%. Anoka County would receive 10.02% of the appropriated funds, and projects would be funded in priority order.
