Subject: Authorization to award contract to ETC Institute to conduct the 2016 Transit On-Board Survey

Proposed Action

That the Metropolitan Council authorize the Regional Administrator to enter into negotiations and to execute a contract with ETC Institute to conduct the 2016 Transit On –Board Survey for an amount not to exceed \$1,350,000

Summary of Committee Discussion/Questions

Metropolitan Transportation Services Senior Planner Katie White presented this item. Letofsky questioned why the survey was more expensive than previously estimated and White explained the high quality product that is expected. She also explained the intent of the survey as it feeds into transportation modeling, and the survey is required by the FTA for New Starts projects. Rodriguez questioned whether this survey would also survey the people who do not use transit. White explained that is part of the Transit Behavior Inventory which is also periodically conducted. Dorfman asked if the subcontractor can be required to have a diverse employment pool doing the work. A. McCarthy said that staff will look at the procurement documents and report back to the committee members.

Proposed Action

That the Metropolitan Council authorize the Regional Administrator to enter into negotiations and to execute a contract with ETC Institute to conduct the 2016 Transit On-Board Survey for an amount not to exceed \$1,350,000.

Background

The Transit On-Board Survey is conducted every five years as part of the transportation planning process. The Survey will contribute valuable data to the region's Travel Demand Forecast Model, help planners understand key transit markets, and provide information to the federally required before and after studies for the Green Line, Green Line Extension and Blue Line Extension projects. The survey will provide data for riders on all fixed-route bus and rail service from all providers in the region. The survey work will take place in two phases in the spring and fall of 2016.

An RFP was issued on October 29, 2015 and one addendum was issued. Five people served on the evaluation panel: two from Metropolitan Transportation Services, two from Metro Transit, and one from MnDOT. The evaluation criteria were: (1) qualifications and experience of the proposer, (2) key personnel qualifications; (3) proposer's understanding of the objectives of the project; (4) quality of the proposal; and (5) price of the proposal. Three proposals were received.

After evaluating the three proposals received, the evaluation panel recommended that ETC Institute be awarded the contract. The proposal demonstrated the necessary qualifications and experience to successfully complete the work, including experience in similar survey projects for several peer agencies. The timeline proposed was reasonable and the proposal guaranteed a fixed number of valid and completed surveys. The evaluation panel reached consensus that the proposal submitted by ETC Institute represents the best value to the Council.

Rationale

The Transit On-Board Survey will provide data for use by the Council and local partners in developing transit projects.

Funding

The total cost of this project is estimated to be \$1,350,000 with a projected expenditure of \$1,100,000 in 2016. The Transportation Advisory Board approved \$800,000 in federal Surface Transportation Program (STP) funding for this project. In the Council's 2016 Operating Budget, \$1,100,000 is dedicated to this project, consisting of the \$800,000 STP funds and a \$300,000 match from the Council. The remaining funds will be committed by the Council in 2017 through the budgeting process.
