**Background**

With the implementation of MAP-21 (effective October 1, 2012), the previous Job Access and Reverse Commute (JARC) and New Freedoms programs under SAFETEA-LU were merged into the 5310 grant program and the distribution of 5310 funds changed accordingly. Under MAP-21, sixty percent of the state’s funds are for the urbanized areas (population of 200,000 or more). 5310 grant funds assists governmental organizations and private nonprofit groups in meeting the transportation needs of the elderly and persons with disabilities.

In July 2013, the Metropolitan Council authorized staff to take the necessary steps to designate the Minnesota Department of Transportation (MnDOT) as the recipient of MAP-21 formula grants allocated to the Minneapolis-St. Paul urbanized area. MnDOT has a long and successful history with statewide administration of the 5310 program. The Council entered into a memorandum of understanding (MOU) with MnDOT to clarify roles and responsibilities of the relationship.

**Rationale**

MnDOT, Council and other government entities staff evaluated 12 projects from the metropolitan area. The panel is recommending all 12 projects. Three mobility management projects will be renewed for 2017. In addition, the project list includes 16 replacement buses and 3 new buses.

Staff is asking the Metropolitan Council to approve these projects prior to incorporation into the Transportation Improvement Plan (TIP).

### **Funding**

The total amount of 5310 funding for 2017, designated for the metro area, is \$1,936,203. The total value of grants recommended for 2017 is \$1,963,200. The difference between the 2017 allocation and grant awards will be covered with unspent 2016 funds. Matching local funds for the 15 projects is \$490,800 for total project costs of \$2,454,000.
