#### Background

On September 28, 2016, the Council approved Business Item 2016-192 authorizing the Regional Administrator to submit grant applications to CTIB for 2017 funding. On October 26, 2016, the Council approved Business Item 2016-211 stating these grant applications were consistent with the adopted 2040 Transportation Policy Plan. All submitted grants were approved by CTIB. This proposed action will allow agreements to be executed with CTIB to accept the grant awards.

All CTIB capital and operating grants are subject to standard conditions including narrative and financial reports. Additional special conditions of note include the following:

Orange Line

- The formation of an Executive Change Control Board (ECCB) for the project is required. This
  board will be similar to the existing ECCB on the Green Line Extension project. Council
  Members chair and serve on corridor ECCBs.
- Additional CTIB approval is required to expend \$5 million of the 2017 grant, through a Letter of No Prejudice (LONP) expenditure approval.

### SouthWest LRT

• Council is required to develop a schedule and related documents for the Full Funding Grant Agreement and Certificates of Participation for CTIB review and approval.

#### Blue Line LRT

 No disbursement of funds is permitted for Engineering until FTA has approved entry into New Starts Engineering.

#### Rationale

CTIB operating grant funds will provide up to 50% of the net cost of transitway operations for calendar year 2017. CTIB capital grant funds will provide a funding share ranging from 30 to 60%. Capital grants will fund transit station construction, engineering, and project development work.
