Summary of Committee Discussion/Questions

Metro Transit Planner Scott Janowiak and Project Manager Katie Roth presented this item.

Rodriguez asked if the non-traditional outreach and engagement activities provided a more well-rounded perspective on the project within the community. Janowiak commented that additional public outreach activities like door knocking or pop-up outreach help ensure the comments and opinions of the entire community are captured.

Letofsky asked if the public engagement process identified potential for people who do not currently ride Route 19 to begin using the C Line. Janowiak noted that comments received indicate an appeal for non-transit riders.

Commers asked about arterial BRT naming conventions and considerations to rename the C Line the B Line. General Manager Lamb noted ongoing conversations at the staff level regarding arterial BRT line naming conventions. Roth stated the geography and timing of project development for future arterial BRT lines could contribute to confusion, but that arterial BRT naming conventions remain under consideration as projects advance.

Proposed Action

That the Metropolitan Council:

Background

The recommended *C Line Station Plan* identifies station locations for the C Line bus rapid transit (BRT) corridor. Recommended station locations result from planning activities that began in 2013 and continued through the end of 2015 in partnership with Hennepin County and the City of Minneapolis.

A draft version of this plan was published on November 6, 2015. Comments on the draft *C Line Station Plan* were accepted through December 20, 2015. Five open houses, transit rider outreach, and neighborhood meetings were held during this comment period to gather input on planned station locations. Over 150 comments were received. Upon completion and approval, the plan will identify the final planned locations for C Line stations in advance of detailed design and engineering.

Rationale

The proposed comment period continues transparent and meaningful discussion with the public about the C Line. It also provides an opportunity for staff and the Council to better understand the components of the recommended *C Line Station Plan* that are important to communities in the corridor.

Funding

The C Line planning process has been funded using Metro Transit operating budget resources. Full funding for delivery of the C Line project is not yet identified.

Known Support / Opposition

Public engagement on the draft plan has identified strong support for the C Line and transit improvements in the Penn Avenue corridor. Local partners have been supportive of the project and will continue to be closely involved as the project transitions into the detailed design and engineering phase.
