Proposed Action

That the Metropolitan Council approve resolution 2016-10 authorizing the Regional Administrator to apply for Section 5311 Non-Urbanized Area Formula Program funding from the Minnesota Department of Transportation.

Background

The Federal Transit Administration (FTA) apportions the funds appropriated annually to the Chief Executive Officer of each state for public transportation projects in non-urbanized areas. Within Minnesota, these funds are administered by MnDOT. Eighty percent of the statutory allocation is based on the non-urbanized population within the state and 20% is based on land area. Based on 2010 census data, the seven county metro area accounts for 11.3% of the state's non-urbanized area population and 2.4% of the state's non-urbanized geographic area.

MnDOT oversees a competitive process to disburse Section 5311 funds, which may be used to fund capital projects at 80% reimbursement or operating costs at 50% reimbursement. Projects funded through this program must serve residents in non-urbanized areas. The Council was awarded a \$725,000 grant for 2016 Transit Link dial-a-ride operations.

Rationale

MnDOT receives over \$12 million dollars annually from the Federal Transit Administration to fund transit services in the non-urbanized areas throughout the state of Minnesota. Non-urbanized population and geographic area within the Council's jurisdiction are included in the federal funding formula. Approval of this resolution will enable the Council to apply for Section 5311 funds to support Transit Link dial-a-ride service in the non-urbanized portion of the metropolitan area.

Funding

MTS will include \$800,000 in 5311 formula funds in its proposed 2017 operating budget. The final budget will reflect the actual 5311 funding award which will be known by late September. The funding will be used to support Transit Link dial-a-ride service in the non-urbanized portions of the seven counties.

Known Support / Opposition

There is no known opposition to the Metropolitan Council applying for these funds.

Resolution Authorizing the Metropolitan Council to
Apply for 2017 Section 5311 (Non-urbanized Area Formula Program) Funding
from the Minnesota Department of Transportation (MNDOT)

Resolved, that the Metropolitan Council enter into an Agreement with the State of Minnesota to receive a Section 5311 (Non-urbanized Area Formula Program) grant to provide public transportation service in the Twin Cities Metropolitan Area.

Further resolved, that the Metropolitan Council agrees to provide a minimum local share of 20% of net capital costs and 50% of net operating costs.

Further resolved, that the Metropolitan Council authorizes the Regional Administrator to execute the aforementioned Agreement and any amendments thereto.
