Subject: Ratification of Emergency Declaration for Wastewater Forcemain in Minnetrista

### **Proposed Action**

That the Metropolitan Council ratify the Emergency Declaration for replacement of Lift Station No. 51 wastewater forcemain in Minnetrista in the estimated amount of \$1,000,000.

### Summary of Committee Discussion/Questions

Staff stated that the L51 forcemain is not able to be inspected without taking the pipe out of service, so the work was not included in the project that is currently contemplated for the Mound and Minnetrista area. Due to the recent breaks that have occurred in the facility since 2015, and because of the condition of the pipe observed during the excavation to repair the pipe, it was determined that MCES replace the pipe under an emergency declaration in order to protect public health and the environment. Since the City of Minnetrista is currently reconstructing the roadway that the pipe is located under, work is being coordinated with Minnetrista's roadway contractor.

When the forcemain broke in 2015 and in 2017, wastewater was released into Lake Minnetonka. Staff performed monitoring and notified the public of the release.

#### **Proposed Action**

That the Metropolitan Council ratify the Emergency Declaration for replacement of Lift Station No. 51 wastewater forcemain in Minnetrista in the estimated amount of \$1,000,000.

#### Background

The 6-inch diameter, 1700 lineal feet ductile iron forcemain from Lift Station No. 51 in Minnetrista has experienced three breaks in the past year, in different sections of the pipe. The cause is external corrosion of the metal pipe due to chemical reaction with the surrounding soils.

Future breaks are likely, which will result in spills to Lake Minnetonka and, potentially, basement backups. Due to public health concern, an emergency has been declared by the Regional Administrator.

The plan is to install new non-corrosive (high density polypropylene pipe) using directional drilling, supplemented by a short section of open-cut pipe installation. Estimated cost is \$1,000,000.

#### Rationale

Emergency Declarations for anticipated expenditures exceeding \$100,000 require Council ratification.

#### **Thrive Lens Analysis**

- Sustainability by protecting water quality;
- Collaboration by working with the City of Minnetrista to coordinate MCES emergency work with the City's pavement management program.

#### **Known Support / Opposition**

MCES staff met with the Minnetrista City Council on Monday, October 16, 2017. A communication plan has been developed to inform affected residents. There is no known opposition.

This force main was placed into service in the early 1970's. It is constructed of ductile iron pipe. On three occasions over the past year there have been force main breaks that resulted in spills to the environment. Examination of the ruptured pipe revealed that in each case the break was a result of external corrosion due to "hot" corrosive soils. The breaks occurred in separate reaches of the force main.
