#### **Proposed Action**

That the Metropolitan Council authorize the Regional Administrator to execute Contract No. 16P270 with Alarm and Communications Systems, Inc. for the procurement of bus and light rail vehicle surveillance system maintenance services for a three-year term in the amount of \$660,960.00.

### **Background**

Metro Transit requires a new contract for the maintenance and repair of bus and light rail surveillance systems to replace the existing expiring maintenance contract. Metro Transit's bus and light rail fleets are equipped with video surveillance systems and these systems require ongoing preventative maintenance and repair. An IFB was issued on December 8, 2016 and three bids were received. The lowest responsive responsible bid submitted by Alarm and Communication Systems, Inc. represents the best value to the Council.

#### Rationale

This investment also reflects the Council's commitment to maintain and preserve regional transit infrastructure investments.

#### **Thrive Lens Analysis**

This procurement, contracted through Alarm and Communications Systems, will ensure reliability of vehicle surveillance systems on bus and light rail equipment which provided 82.6 million rides in 2016. These surveillance systems support the Thrive outcomes of Equity and Livability by providing safe, reliable, and affordable mass transportation to our riders.

#### **Funding**

Funding for this maintenance contract is contained in the bus and light rail vehicle operating budgets.
