## **Proposed Action**

That the Metropolitan Council authorize the Regional Administrator to enter into a lime kiln dust contract with Omni Materials, Inc, for their low responsive, responsible bid of \$79.50 per ton for the first two years and \$82.00 per ton for years three and four. The contract term is four years and not to exceed total cost of \$1,000,000; MCES contract 16P262.

## **Background**

Procurement of goods and services for amounts exceeding \$500,000 require Council approval.

#### Rationale

Lime Kiln Dust (calcium oxide) is used in the alkaline stabilization process at the Metro Wastewater Treatment Plant. The alkaline stabilization process is an alternative sludge treatment utilized when incineration capacity is limited. As an alternative treatment process, the quantity of lime kiln dust use is estimated based upon past equipment performance and anticipated mechanical availability.

The Invitation for Bids (IFB) was issued for the procurement of an estimated 13,000 tons of lime kiln dust over a period of four (4) years. Twelve known or probable vendors were notified of the IFB and where to find the documents. Omni Materials, Inc. submitted the lowest responsive, responsible bid at \$79.50 per ton for the first two years and \$82.00 per ton for year three and four.

#### **Thrive Lens Analysis**
