Subject: Contract Award for Bloomington, Edina, and Roseville Transit Service

### **Proposed Action**

That the Metropolitan Council authorize the Regional Administrator to negotiate and execute a contract with Schmitty & Sons, Inc to provide regular route local transit service within the Bloomington, Edina, and Roseville regular route transit service contract from July 30, 2017 through July 30, 2022 in an amount not to exceed \$24,600,000.

#### **Proposed Action**

That the Metropolitan Council authorize the Regional Administrator to negotiate and execute a contract with Schmitty & Sons, Inc. to provide regular route local transit service within the Bloomington, Edina, and Roseville regular route transit service contract from July 30, 2017 through July 30, 2022 in an amount not to exceed \$24,600,000.

## **Background**

Metropolitan Transportation Services (MTS) provides approximately 10% of the Council's regular route bus transit service through a number of competitively procured, multi-year operating agreements. The service procured by MTS usually consists of routes that have comparatively low productivity that sometimes operate with smaller buses. This specific contract package includes all day local service on weekdays and weekends in a variety of communities throughout the metro area including Bloomington, Edina, Richfield, Roseville, Falcon Heights, and St. Paul.

#### Rationale

A Request for Proposals (RFP) was advertised and posted on the Council's website and all known transit operators were directly invited to propose. Three proposals were received and evaluated by an evaluation panel consisting of staff from Metropolitan Transportation Services, Metro Transit, and MNDOT. In the review of the proposals, four criteria were evaluated: proposal quality, proposer qualifications, proposer experience and price. Proposal price was approximately equal in importance to a combination of all other evaluation criteria. The evaluation panel concluded that the proposal submitted by Schmitty & Sons, Inc. is the most advantageous to the Council.

Proposers submit pricing for a range of service levels, which allows the Council to make adjustments to the service during the five-year term using pre-established rates. The requested not-to-exceed amount of \$24.6 Million allows for a 20% increase in service hours over the current (base) service levels described in the scope of work without amending the contract. The value of the base service level is \$20.7 million.

### **Thrive Lens Analysis**

This item supports several Thrive outcomes. First, it supports Stewardship by using public financial resources efficiently and effectively. In addition, it increases the reach of our public transit system infrastructure which makes our region more attractive to businesses and job creators and reduces the number of vehicles on the road, key components of Prosperity and Sustainability outcomes. Finally, it provides transportation options and mobility, which supports Livability.
