Subject: Roseville Interceptor Rehabilitation & Meter Improvements

Proposed Action

That the Metropolitan Council authorize its Regional Administrator to award and execute a construction contract for Interceptor 1-RV-430, 1-RV-433 and 8851 Rehabilitation and M046 and M049 Improvements, Project 808830, Contract 16P201, to Lametti and Sons, Inc. for their low responsive, responsible bid of \$6,317,700.00.

Summary of Committee Discussion/Questions

Clarification was requested on how the Office of Equal Opportunity determines the percentage requirement for this contract. Staff stated the type of work that needs to be completed is evaluated, after which, the Office of Equal Opportunity and Diversity values the work and compared to the total value that determines the percentage. If more companies have the capability of completing the work, the percentage may be different than if there are fewer or more specific work that is required.

Staff clarified Cured in Place Pipe is a technology that is currently being used to refurbish the existing pipes rather than replacing and causing major disruption to the public in the area. It is used for corroded pipe and is more cost effective. It is unknown currently how long this option will last versus replacing degraded pipe.

Proposed Action

That the Metropolitan Council authorize its Regional Administrator to award and execute a construction contract for Interceptor 1-RV-430, 1-RV-433 and 8851 Rehabilitation and M046 and M049 Improvements, Project 808830, Contract 16P201, to Lametti and Sons, Inc. for their low responsive, responsible bid of \$6,317,700.00.

Background

Recent closed-circuit television inspections found hydrogen sulfide corrosion along reaches of Interceptors 1-RV-430, 1-RV-433, and 8851 located within Roseville and St. Paul. The project includes the relocation of Meter M049, improvements to Meter M046, and the rehabilitation of 5,800 lineal feet of reinforced concrete pipe of diameters ranging from 12-inch to 48-inch using cured-in-place pipe. Maintenance structures will also be rehabilitated or replaced.

The project has a Metropolitan Council Underutilized Business (MCUB) goal of 5%. The Office of Diversity and Equal Opportunity has determined that Lametti and Sons, Inc. has met the goal set for this project.

Rationale

Construction contract awards exceeding \$2,500,000 require Council authorization.
