Proposed Action

That the Metropolitan Council authorizes its Regional Administrator to award and execute a contract for Woodbury L73 Lift Station Access Improvements, Project 805570, Contract 16P176, to Rice Lake Construction, Inc. for their low, responsive bid of \$2,992,400.00.

Background

The L73 lift station is a 73-foot-deep submersible pumping station located in the City of Woodbury along County Road 19 (Woodbury Drive) south of Bailey Road. Initially pump removal was performed from hatches 70 feet above the pumps. This proved to be difficult and a "Deep Lift" system was installed to facilitate pump removal. The "Deep Lift" mechanism proved unreliable, and while it continues to be used, the risk of pump and piping damage, and service disruption still exists. This project will provide an improved access to bottom of the wet well to allow personnel to assist and visually confirm that lifting hook has/remains fully engaged the pump lifting bail throughout the lifting process. It includes a permanent pump retrieval system to eliminate the need to hire a crane to remove the pumps for service. It will also correct elevated wet well hatches that are at an awkward height and provides for ventilation of wet well and access facilities.

The project has a Metropolitan Council Underutilized Business (MCUB) goal of 15%. The Office of Diversity and Equal Opportunity has determined that Rice Lake Construction, Inc. has met the goals set for this project.

Rationale

Construction contract awards exceeding \$2,500,000 require Council authorization.
