**Subject:** Intergovernmental Agreement with the City of Mound and Hennepin County; Joint Powers Agreement with the City of Minnetrista

#### **Proposed Action**

That the Metropolitan Council authorize its Regional Administrator to negotiate and execute intergovernmental agreements with the City of Mound for the construction of city watermain, Hennepin County for the construction of drainage and roadway improvements, and a joint powers agreement with the City of Minnetrista for acquisition of real property.

## **Summary of Committee Discussion/Questions**

Staff clarified additional public meetings will occur as the project progresses. The City of Minnetrista has requested a presentation to the City Council.

An inquiry was made if the road would be closed during the project. Staff stated the project will be phased to minimize road closures. It is an open-cut project that will require detours. County Road 44 will require a regional detour.

The project is an upgrade as we will be providing dual forcemain for the region and meeting the needs of the 2040 requirements.

# **Proposed Action**

That the Metropolitan Council authorize its Regional Administrator to negotiate and execute intergovernmental agreements with the City of Mound for the construction of city watermain, Hennepin County for the construction of drainage and roadway improvements, and a joint powers agreement with the City of Minnetrista for acquisition of real property.

### **Background**

The Mound 7021 forcemain project will replace nearly 3 miles of existing MCES 24" forcemain with 2-18" forcemains along County State Aid Highway 44, commencing at L38 in Mound and discharging to gravity pipe in Lake Minnetonka Regional Park in Minnetrista.

MCES has a desire to eliminate direct local connections to its forcemain system when reconstructing new facilities, which will result in modifications to the Minnetrista forcemain system. Because of these changes, easement acquisition is necessary for the City to reasonably operate their infrastructure long-term. MCES must enter into a Joint Powers Agreement with Minnetrista in order to obtain an easement on their behalf.

As part of this project, we will enter into cooperative agreements with the City of Mound to remove and replace watermain and with Hennepin County to install drainage improvements. By working in a cooperative manner with these respective agencies, we can minimize the impacts to the community and participate in cost sharing for roadway and restoration costs.

This project will be constructed under the proposed intergovernmental agreement with the City of Mound and Hennepin County. This project is scheduled for construction during 2018-2020 with an estimated Metropolitan Council cost of \$25,000,000.

#### Rationale

Intergovernmental Agreements with a City exceeding \$500,000 requires Metropolitan Council authorization.
