Proposed Action

That the Metropolitan Council adopt Resolution 2017- 22 (attached) as required by Minnesota Housing, to authorize the Director of the Housing and Redevelopment Authority to execute a continuation grant agreement for the Rental Assistance for Anoka County (RAAC) Program.

Background

The Council's Housing and Redevelopment Authority (Metro HRA), in partnership with Anoka County, has administered the RAAC program since 2002. RAAC provides a tenant-based housing subsidy to Anoka County families receiving Minnesota Family Investment Program (MFIP) funds. Program participants must be compliant with their employment and self-sufficiency obligations. Participating families receive a maximum subsidy of \$400 towards their monthly rent. The program promotes the attainment of economic self-sufficiency through the provision of the shallow rent subsidy.

The current grant period will expire on September 30, 2017. The renewal funding award of \$555,000 will allow continued rent assistance support for the next biennium which runs from October 1, 2017 through September 30, 2019. The grant amount will support the current program size of 54 families through the term of the grant.

Rationale

The Metropolitan Council provided renewed approval for continued administration and authorized staff to execute grant agreements for the RAAC program as required by Minnesota Housing Finance Agency.

Thrive Lens Analysis

This action demonstrates stewardship and equity through the efficient delivery of rent assistance to persons working towards economic self-sufficiency.

Funding

The funding award of \$555,000 is for the period October 1, 2017 through September 30, 2019.

RESOLUTION AUTHORIZING THE DIRECTOR OF THE METROPOLITAN COUNCIL HOUSING AND REDEVELOPMENT AUTHORITY (METRO HRA) TO EXECUTE A GRANT AGREEMENT WITH MINNESOTA HOUSING FOR THE RENTAL ASSISTANCE FOR ANOKA COUNTY PROGRAM

WHEREAS:
