### **Proposed Action**

- 1. That the Metropolitan Council approve a grant in the amount of \$1,000,000 to reimburse the Minneapolis Park and Recreation Board for the construction of a natural filtration swimming pool, bathhouse and site improvements at North Mississippi Regional Park. The grant will be funded from the North Mississippi Regional Park Fund account.
- 2. Authorize the Community Development Director to execute the grant agreement on behalf of the Council.

### Background

Minneapolis Park and Recreation Board (Park Board) requests that the Council approve a grant for \$1,000,000 to reimburse the construction costs of Webber Pool, a natural filtration swimming pool, bath house, and site improvements (Figure 1).

### Rationale

The grant request is in response to a 2013 Metropolitan Council business item (2013-205), which included an action to "consider reimbursing the Minneapolis Park and Recreation Board up to \$1,000,000 from the North Mississippi Regional Park Fund account for the construction of a natural filtration swimming pool, bathhouse and site improvements at North Mississippi Regional Park, when that amount of interest has been earned on the Council's park bonds in accordance with State law".

#### **Thrive Lens Analysis**

This request is consistent with Thrive's livability outcome by increasing access to additional outdoor recreation opportunities, thereby enhancing the region's quality of life.

#### **Funding**

The Council will fund the requested grant with the North Mississippi Regional Park Fund account, established by the Legislature in 1985 to acquire and develop the park. Specifically, MN Laws 1985, First Special Session, Chapter 15, Section 5, Subdivision 2(b), and MN Laws 1987, Chapter 384, Article 3, Section 45, and MN Laws 1998, Special Session, Chapter 1, Article 3, Section 12 direct the Metropolitan Council to establish a separate account of interest earnings on park bonds and to grant funds from the account for the acquisition and development of North Mississippi Regional Park.



## Known Support / Opposition

The Metropolitan Parks and Open Space Commission unanimously recommended approval of the proposed action at its meeting on January 2, 2018. The Minneapolis Park and Recreation Board has approved the project funding for which they are seeking grant reimbursement. There is no known opposition.

### Background

Minneapolis Park and Recreation Board (Park Board) requests that the Council approve a grant for \$1,000,000 to reimburse the construction costs of Webber Pool, a natural filtration swimming pool, bath house, and site improvements (Figure 1). The request is in response to a 2013 Metropolitan Council business item (2013-205), which included an action to "consider reimbursing the Minneapolis Park and Recreation Board up to \$1,000,000 from the North Mississippi Regional Park Fund account for the construction of a natural filtration swimming pool, bathhouse and site improvements at North Mississippi Regional Park, when that amount of interest has been earned on the Council's park bonds in accordance with State law".

Webber Pool is located within North Mississippi Regional Park in Minneapolis, which is located along the Mississippi River, extending from the Camden Bridge area to the I-694 bridge in Brooklyn Center. The regional park boundary includes approximately 94 acres.




Figure 2: North Mississippi Regional Park Master Plan Boundary

The Council approved a regional park master plan and regional park boundaries in 1987, and subsequently two amendments in January 2003, and in July 2013. In the latter amendment (business item <u>2013-205</u>), the Council approved a regional park boundary expansion to include 16.24 acres of Webber Park as shown in Figure 2 (attached).

The Park Board completed the construction project, and now requests the reimbursement grant.

### Rationale

The grant request is consistent with the 2040 Regional Parks Policy Plan, Finance Strategy 6, which states, in part, the "Council may reimburse regional



park implementing agencies for the costs of acquiring some lands before they have been made part of the Regional Parks System, or for development projects undertaken before they can be financed through the Metropolitan Regional Parks Capital Improvement Program." The grant request is also consistent with the Council's action in business item <u>2013-205</u>, authorizing the reimbursement consideration.

### **Thrive Lens Analysis**

This request is consistent with Thrive's livability outcome by increasing access to additional outdoor recreation opportunities, thereby enhancing the region's quality of life.

### Funding

The Council will fund the requested grant with the North Mississippi Regional Park Fund account, established by the Legislature in 1985 to acquire and develop the park.
