Subject: St. Paul and Minneapolis Transit Service Contract

#### **Proposed Action**

That the Metropolitan Council authorize the Regional Administrator to negotiate and execute contract 18P309 with Metropolitan Transportation Network, Inc. to provide regular route local and limited stop transit service from December 1, 2018, through July 31, 2020, in an amount not to exceed \$4,071,725.

#### **Summary of Committee Discussion/Questions**

John Harper presented this item. Paul Slattery with Teamsters Union 120 spoke in opposition to the business item based on the lack of a competitive procurement process for selecting the vendor. Councilmember Elkins asked why a competitive process was not used. Director Nick Thompson replied that a typical solicitation process takes about 10 months and a faster implementation timeline is needed on this work in order to maintain service levels. Thompson added that the long-term plan for these routes is to package them with several others into a larger contract package. The process of competitively procuring a multi-year contract for that package will begin next year.

### **Proposed Action**

That the Metropolitan Council authorize the Regional Administrator to negotiate and execute contract 18P309 with Metropolitan Transportation Network, Inc. to provide regular route local and limited stop transit service from December 1, 2018, through July 31, 2020, in an amount not to exceed \$4,071,725.

#### **Background**

The Council provides transit service both as directly operated service, under the Metro Transit division, and using contracted providers, under the MTS division. Lower productivity routes are assigned to MTS, often using smaller buses that can be operated at a reduced cost, in an effort to avoid route elimination. Periodically, Metro Transit reviews route performance to determine if routes should be reassigned to MTS as a way to retain the service for customers. Metro Transit approached MTS for assistance in maintaining service schedules through private provider contracts on four routes, with the MTS operations beginning in December.

#### **Rationale**

Metropolitan Transportation Network, MTN, approached Council procurement staff in June with an unsolicited offer to operate regular route service on behalf of the Council. MTN operates bus service for Hennepin County and various school districts across the region and has proposed on Council procurements over the past few years. Council staff saw the offer as an opportunity to help preserve scheduled service and to increase the pool of experienced vendors for future procurements.

In response to MTN's offer, Metro Transit and MTS compiled a set of services that would fit within MTN's offer and meet the need to reassign routes to MTS. MTN accepted that offer at an hourly rate that is commensurate with MTS' expectations, based on current hourly rates in other contracts.

#### **Thrive Lens Analysis**
