Management Summary of Committee Discussion/Questions

Theresa Nistler, Assistant IT Director in the Council's Information Services Department, presented Business item 2018-160 JT. Council Member Melander asked if this item had been included in the new IT governance process. The Council has a number of projects that are currently in flight and have not been linked to the new IT governance process and policy as it is in the process of being implemented. Chair Chávez asked if the access to data had been compromised. No, we have not had any data issues related to this topic. Chair Chávez asked if the IT governance process had been in place would this item have gone through the process. Yes, the LENS project would have gone through the process and approved. We have broad collaborative support on this project from the BCA, Regional Administration, Metro Transit, Metro Transit Police Department and Information Services.
