Proposed Action

That the Metropolitan Council concur with the Transportation Advisory Board (TAB) action to amend the 2018-2021 Transportation Improvement Program (TIP) to change the cost of the City of Minneapolis's 6th Street Overhead Signal Additions Project.

Background

This amendment is needed due to a cost-reduction resulting from the City of Minneapolis's scope change request to remove two pedestrian curb ramps, two accessible pedestrian signals, and two pedestrian countdown timers from its 6th Street Overhead Signal Additions Project (SP # 141-030-036). These elements are being removed because they are slated to be completed as parts of a different project. While these elements are being removed and two curb extensions are being added, the project description remains unchanged.

Rationale

The Transportation Advisory Board approves formal amendments to the TIP and the Metropolitan Council concurs with the action of the TAB. The project is consistent with the Transportation Policy Plan (TPP) and meets fiscal constraint because the federal and local funds are sufficient to fully fund the project. The Minnesota Interagency Air Quality and Transportation Planning Committee determined that the project is exempt from air quality conformity analysis. This TIP amendment is associated with a scope change request approved by TAB on February 21, 2018.

This action promotes *stewardship* because it is being done in response to the City of Minneapolis securing funds from other sources.

PROJECT BACKGROUND:

The project scope is changing to remove pedestrian curb ramp upgrades, accessible pedestrian signals (APS), and pedestrian countdown timers at 1st Ave N & 6th St N and Hennepin Ave S & 6th St S. This TIP amendment is needed to update the project funding accordingly.
