### Proposed Action

That the Metropolitan Council concur with the Transportation Advisory Board (TAB) action to amend the 2018-2021 Transportation Improvement Program (TIP) to amend the scope of the City of Minneapolis's University of Minnesota Protected Bikeways Project.

### Background

This TIP amendment is requested to remove the 0.5-mile segment of 10<sup>th</sup> Ave Bridge between University Ave SE and 2<sup>nd</sup> St S and add a 0.25-mile segment to 10<sup>th</sup> Ave SE between 5<sup>th</sup> St SE and 8<sup>th</sup> St SE on the University of Minnesota Protected Bikeways Project. Removal of the bridge from the project is necessary because the work will be completed on a separate 10th Avenue Bridge project.

### Rationale

The Transportation Advisory Board approves formal amendments to the TIP and the Metropolitan Council concurs with the action of the TAB. The project is consistent with the Transportation Policy Plan (TPP) and meets fiscal constraint because the federal and state funds are sufficient to fully fund the project. The Minnesota Interagency Air Quality and Transportation Planning Committee determined that the project is exempt from air quality conformity analysis. This TIP amendment is associated with a scope change request approved by TAB on February 21, 2018.

### Thrive Lens Analysis

This action promotes *stewardship* by leveraging other funds to complete part of the project and *livability* by extending the project and thereby increasing bicycle connectivity.

### Funding

The project is fully funded with federal and local funds.

This amendment is needed to remove the 0.5-mile segment of 10<sup>th</sup> Ave Bridge between University Ave SE and 2<sup>nd</sup> St S and add a 0.25-mile segment to 10<sup>th</sup> Ave SE between 5<sup>th</sup> St SE and 8<sup>th</sup> St SE.
