**Subject:** Seneca Polymer Contract

### Proposed Action

That the Metropolitan Council authorize its Regional Administrator to award and execute a contract to Polydyne, Inc. of Riceboro, GA to provide Clarifloc polymers at a unit price of \$0.85 per pound delivered to the Seneca Wastewater Treatment Plant for the period June 1, 2018 through May 31, 2023. This contract will be for a period of two years with an option to extend for three additional one-year periods with the total procurement not to exceed \$3,750,000.

Clarification was provided regarding how the testing is performed. The product that does the best job with the lowest amount of product required, is typically determined as passing the testing process.

### Proposed Action

That the Metropolitan Council authorize its Regional Administrator to award and execute a contract to Polydyne, Inc. of Riceboro, GA to provide Clarifloc polymers at a unit price of \$0.85 per pound delivered to the Seneca Wastewater Treatment Plant for the period June 1, 2018 through May 31, 2023. This contract will be for a period of two years with an option to extend for three additional one-year periods with the total procurement not to exceed \$3,750,000.

### Background

Polymer is a conditioning chemical, which aids in the removal of water while processing sludge solids on mechanical equipment such as centrifuges and belt presses. A formal, advertised Invitation for Bids was issued on December 8, 2017. Two bids were received and opened on February 1, 2018.

Following the receipt of sealed polymer bids, an evaluation process is conducted which includes a full-scale evaluation of polymer performance along with an evaluation of the bids to identify the most effective polymer at the lowest cost to the Council. At the conclusion of this process, Polydyne, Inc. was determined to be the vendor that met evaluation process requirements.

Polymer unit costs ranged from \$53-\$57 per dry ton of sludge processed. This contract will be for a period of two years with an option to extend for three additional one-year periods. Estimated expenditures for this procurement are \$750,000 annually.

### Rationale

Council authorization is required for purchases over \$500,000.
