Proposed Action

Background

All projects were reviewed and adopted into the Council Unified Budget by the Metropolitan Council through Business Item <u>2017-118</u>.

Rationale

The requested action will authorize the Regional Administrator to execute grant agreements on behalf of the Metropolitan Council, consistent with the previous action of adopting projects into the Council's Authorized Capital Program.

Thrive Lens Analysis
