Proposed Action

That the Metropolitan Council authorize modifications to Metropolitan Council Procedure 3-3C Delegation of Procurement and Contract Authority, by delegating the approval of construction contract change orders for the Green Line Extension and Blue Line Extension Light Rail Transit Projects as shown below in the "(Proposed)" column, for those change orders that do not exceed \$2.5 million each and do not exceed a cumulative expenditure amount of 10% of the construction contract value, without Council approval.

Background

Council Procedure 3-3C: Expenditures Section II.2.E. authorizes senior managers or their delegate to "Approve construction contract change orders such that the cumulative change order amount does not exceed 10% of the originally-approved contract amount. Construction change orders that exceed this limit must be authorized by staff with sufficient signature authority." Section II.3 of the procedure was updated with special authorizations for approval of construction contract change orders for Hiawatha and Central Corridor Light Rail projects. Specifically, for Central Corridor, the Council delegation of authority is as shown in the "(Current)" column of the table above.

Staff are requesting that the Council approve updates to these delegations of change order authority for the Green Line Extension and Blue Line Extension Light Rail Transit Projects to reflect updated position titles and maximum authority levels.

Staff will provide quarterly updates on change orders to the Transportation Committee.

Rationale

The process described above is designed to ensure the Metropolitan Council's oversight of the process and use of funds, while also ensuring that construction managers can make expedient and responsive decisions in the field.

The Project Director level is proposed to remain unchanged at \$350,000, which aligns with the Executive Change Control Board (ECCB) approval level. The ECCB reviews and approves all change orders of \$350,000 or more. Full execution of a change order of \$350,000 or greater will require both ECCB approval and the corresponding Council or Council official approval. ECCB voting representatives include members from Hennepin County, Hennepin County Regional Railroad Authority and the Metropolitan Council.
