Proposed Action

That the Metropolitan Council authorize the Regional Administrator to negotiate and execute a contract with First Transit, Inc. to provide regular route transit service from June 1, 2019 through May 31, 2023 in an amount not to exceed \$11,622,310.

Background

Metropolitan Transportation Services provides regular route transit service under contract with private companies. These services are competitively procured using a series of multi-year contracts which allows the potential for multiple vendors to propose on and operate transit service on behalf of the Council. This specific contract package includes all day local service seven days a week in a variety of communities in the metro area including St Paul, Minneapolis, Roseville, Falcon Heights, St Louis Park, Minnetonka, Hopkins, Brooklyn Park, Brooklyn Center, Crystal, and Robbinsdale.

Rationale

A Request for Proposals (FRP) was advertised and posted on the Council's website and all known transit operators were directly invited to participate. Two proposals were received and evaluated by an evaluation panel consisting of staff from Metropolitan Transportation Services, Metro Transit, and MNDOT. In the review of the proposals, four criteria were used: proposal quality, proposer qualifications, proposer experience, and proposal weighted price. Price was approximately equal in importance to a combination of the other criteria. The Evaluation Panel concluded that the proposal submitted by First Transit Inc. is the most advantageous to the Council.

The proposal and contract structure allow the Council to adjust service during the term using preestablished rates. The value of the base service level is approximately \$10.0M and the requested contract value of \$11.6M allows for the service hour increases up to 20%.
