Subject: Intergovernmental Agreement with Hennepin County

Proposed Action

That the Metropolitan Council authorize its Regional Administrator to negotiate and execute an intergovernmental agreement with Hennepin County for the construction of a 1,200-foot segment of forcemain within MCES Interceptor 7113 as part of the County's Tanager Bridge Replacement.

Summary of Committee Discussion/Questions

Chair Lindstrom requested clarification on the rationale for replacing forcemain with a bridge constructed over it Staff stated the current plans are to have pilings for the bridge abutments driven within close proximity or on top of our existing pipe that would affect the stability and integrity of the existing forcemain.

Committee Member Sterner inquired about the type of bridge that will be built. Staff stated plans are under development by Hennepin County and has that detail not been determined at this time.

Proposed Action

That the Metropolitan Council authorize its Regional Administrator to negotiate and execute an intergovernmental agreement with Hennepin County for the construction of a 1,200-foot segment of forcemain within MCES Interceptor 7113 as part of the County's Tanager Bridge Replacement.

Background

Hennepin County plans to replace their bridge over the Tanager Lake channel in the City of Orono in 2020 due to the current bridge no longer being sustainable for future use. MCES forcemain 7113 is located within an MCES-owned easement on the west side of the bridge. The County's project will require relocation of this pipe from the under the footprint of the new bridge to avoid damaging the existing pipe and continue to maintain and operate the forcemain in the future.

This project will be constructed under the proposed intergovernmental agreement with Hennepin County. This project is scheduled for construction in 2020-2021 with an estimated Metropolitan Council cost of \$500,000.

Rationale

Intergovernmental agreements with an agency exceeding \$500,000 require Metropolitan Council authorization.
