### **Proposed Action**

That the Metropolitan Council authorizes the Regional Administrator to amend the current grant agreement, #SG-2017-024, with Minnesota Valley Transit Authority (MVTA) by increasing the dollar amount by \$1,285,000.

### **Background**

This amendment will increase sub-grant agreement #SG-2017-024 for MVTA's CAD, AVL, and AVVAS project from \$1,700,000 to \$2,985,000.

The project supports on-board technology implementation including computer aided dispatch and automatic vehicle location.

#### **Rationale**

The requested action will allow MVTA to pay for their CAD, AVL, and AVVAS project using its federal formula earnings.
