Subject: Metro Transit Police Department – Fleet Purchase

Proposed Action

That the Metropolitan Council authorize the purchase of 11 fleet vehicles, equipment and installation of equipment for an amount not to exceed \$880,000.

Summary of Committee Discussion/Questions

Metro Transit Police Department Lieutenant Steven Bakeberg and Procurement Director Jody Jacoby presented this item. Council Member Cummings asked what happens to the fleet vehicles once they reach useful life. LT Bakeberg responded that the vehicle will be returned to the Non-Revenue Maintenance department and sold at a state auction.

Council Member Sterner asked if MTPD has looked at using hybrids or electric cars. LT Bakeberg stated one of the vehicles procured in this purchase will be a hybrid-electric vehicle which will serve as a test pilot for the department.

Council Member Fredson asked if the vehicles being purchased will be America made. LT Bakeberg responded the vehicles being purchased will be Ford Explorers.

Motion by Sterner, seconded by Zeran. Motion carried, **consent** to Council.

Proposed Action

That the Metropolitan Council authorize the purchase of 11 fleet vehicles, equipment and installation of equipment for an amount not to exceed \$880,000.

Background

Metro Transit Police Department recently expanded the department size due to police services needed on the C-Line BRT route. An increase in police officers and jurisdiction has resulted in an increased need for additional vehicles. Six of the 11 fleet vehicles are due to expansion.

Metro Transit Police Department will also be purchasing and replacing 5 fleet vehicles that have reached the end of their useful life and age.

The vehicles, amounting to approximately \$430,000, will be purchased from a State of Minnesota, Cooperative Procurement Venture (CPV) from Tenvoorde Motor Co (contract #158505/ Release A-174(5)). The CPV satisfies the competitive procurement process.

The additional spend will be to outfit the vehicles with emergency equipment and technology, including installation. This equipment will be purchased through either a State of Minnesota CPV or with a competitive bidding process.

The vehicles were included in the adopted 2019-24 Capital Improvement Plan.

Rationale

Purchases greater than \$500,000 requires council approval.

Thrive Lens Analysis

Approval of this procurement will support the Council's Thrive Outcomes of Stewardship and Livability.

Maintaining the police fleet in a state of good repair and procurement through the competitive process (state contract) demonstrates the Council's commitment to **Stewardship** of public financial resources.

The presence of Transit Police officers along with the mobility for them to move throughout the system to provide that presence and answer calls for service will certainly improve the

Livability of the C Line as well as the entire transit system.

Funding

The purchase is fully funded with local funds in capital project 65790 Capital Equipment.
